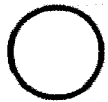

145. Crash Description/Narrative

On 06/16/2017 at approximately 1924 hours, a two car motor vehicle crash occurred on Route 88 eastbound in the area of Route 70. Vehicle #2 was traveling in the left lane and Vehicle #1 was traveling directly behind it. Vehicle #2 stopped suddenly to avoid striking a pedestrian and was struck from behind by Vehicle #1.

Driver of Vehicle #1 stated Vehicle #2 stopped suddenly because of the pedestrian that was standing on the median attempting to cross over the roadway of Route 88. He stated he applied his brakes and attempted to avoid the crash, but he "did not have enough time."

Driver of Vehicle #2 stated the pedestrian that was located on the median had begun to walk into the roadway, and she "slammed" on her brakes to avoid colliding with the pedestrian, but her vehicle from behind by Vehicle #1.

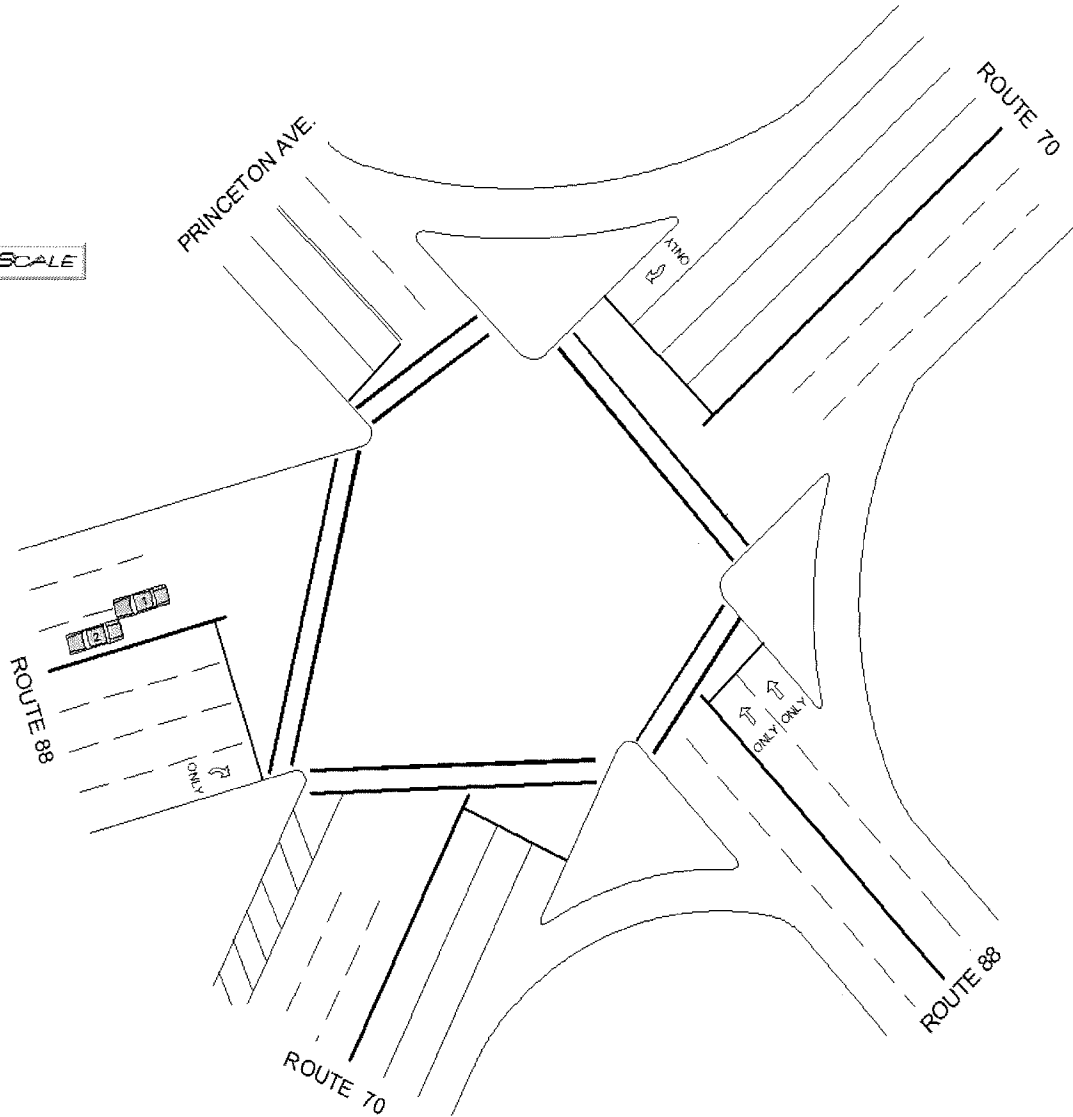
