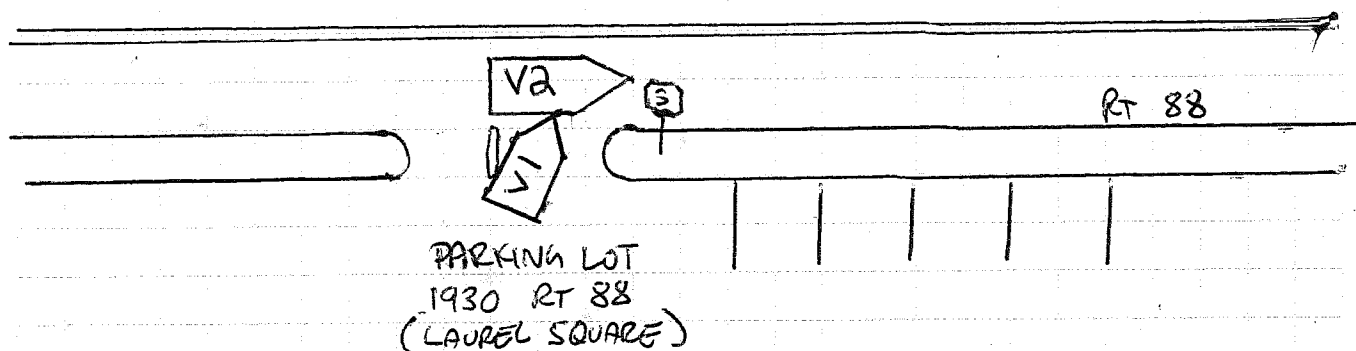

145. Crash Description/Narrative

V2 WAS TRAVELING WEST IN TRAFFIC ON RT 88.
V1 WAS STOPPED AT THE STOP SIGN EXITING THE PARKING LOT OF LAUREL SQUARE AT 1930 RT 88.
DRIVER 1 STATED HE BELIEVED V2 WAS ALLOWING HIM TO ENTER THE HIGHWAY AS IT SLOWED IN TRAFFIC.
DRIVER 2 STATED SHE SLOWED WITH TRAFFIC, BUT DID NOT MOTION FOR OR INTEND TO ALLOW V1 TO ENTER.
V1 ENTERED THE ROADWAY AS V2 DROVE BY.
THE FRONT OF V1 STRUCK THE RIGHT SIDE OF V2, CAUSING DAMAGE.

V2 WAS DISABLED AND WAS TOWED FROM THE SCENE BY JOES SERVICE CENTER, MANTOLOKUNG RD, BRICK NJ.
