145. Crash Description/Narrative

Investigation at the scene indicated the following: Vehicle 2 was parked and unoccupied in the Walmart parking lot. Walmart's video surveillance showed vehicle 1 traveled north in the Walmart parking lot towards Jack Martin Boulevard. Vehicle 1 then made a U-turn through the empty parking spaces just north of vehicle 2. As the vehicle turned, the passenger side of vehicle 1 struck the front driver side bumper of vehicle 2. Vehicle 1 then traveled south towards the Walmart store, and fled the parking lot onto Route 70 east. The victim's bumper did not have paint transfer from the suspect vehicle, but I was able to identify the suspect vehicle as a newer model white Ford Transit. I was unable to obtain the license plate number because of the video's poor quality.

The owner of vehicle 2 stated that he parked his vehicle in the Walmart parking lot around 1530 hours. When he returned to his vehicle at 1600 hours, the front bumper of his vehicle was on the ground.

I checked the surrounding area and was unable to locate the suspect vehicle.

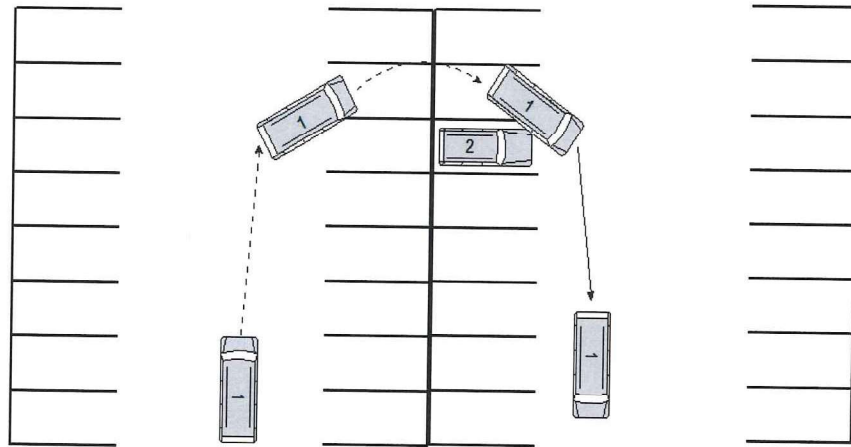
