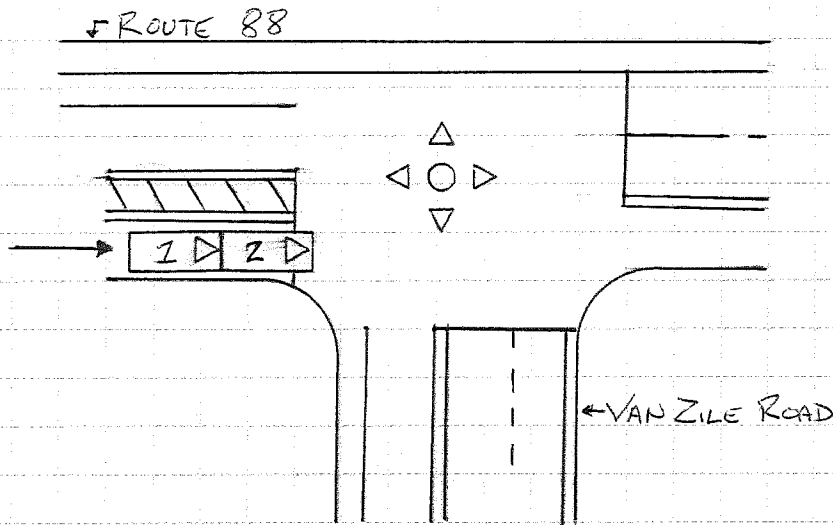

145. Crash Description/Narrative

DRIVER 1 STATED SHE WAS BEHIND VEHICLE 2 AT THE RED LIGHT, WEST ON ROUTE 88. VEHICLE 2 BEGAN TO START IN TRAFFIC TO MAKE A RIGHT TURN. DRIVER 1 STATED VEHICLE 2 STOPPED QUICKLY AND SHE (DRIVER 1) WAS UNABLE TO STOP IN TIME, REAR ENDING VEHICLE 2.

DRIVER 2 STATED SHE WAS STOPPED AT THE RED LIGHT WEST ON ROUTE 88. SHE STARTED IN TRAFFIC TO MAKE A RIGHT TURN ONTO VAN ZILE ROAD WHEN VEHICLE 1 REAR ENDED HER.

INVESTIGATION REVEALED THAT THE CAUSE OF THE CRASH WAS DRIVER 1 FOLLOWING TOO CLOSE BEHIND VEHICLE 2 WHILE STARTING IN TRAFFIC.
