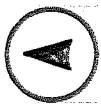

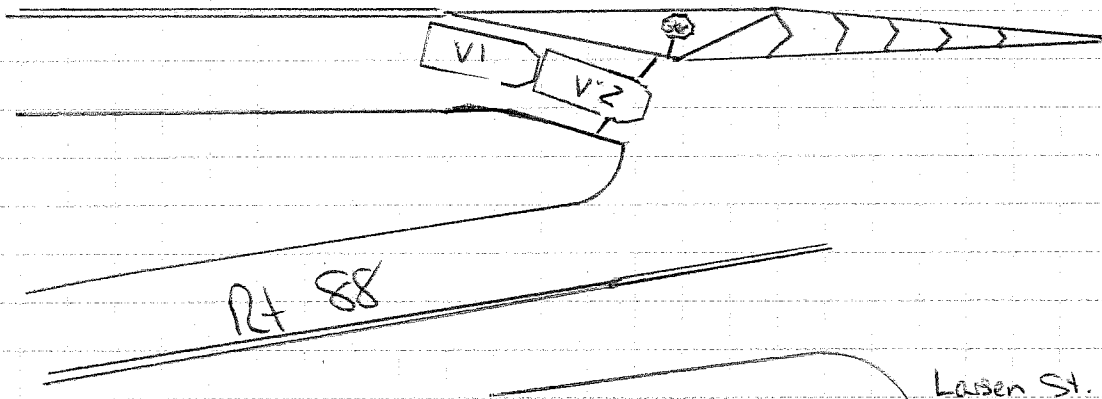

145. Crash Description/Narrative

Crash occurred on Burnsville Rd southbound, approximately 50 feet north of Rt 88. Driver #2 stated she was stopped at the stop sign, waiting for traffic to clear when she was struck from behind by vehicle #1. Driver #1 stated she was stopped behind vehicle #2. She advised vehicle #2 started to go, so she moved forward and began looking to the right to see if it was clear; however unbeknownst to her, driver #2 didn't go and driver #1 hit the rear of driver #2. Driver #1 advised she was not hurt. Driver #2 originally had complaint of neck pain. She was checked out by first aid on scene and ~~refused~~ further medical attention saying she was okay. As I spoke to her further, she advised the soreness was coming back but would get checked out on her own.
