145. Crash Description/Narrative

Vehicle #1 collided with Vehicle #2 in a rear end crash while traveling eastbound in RT 88.

The Driver of Vehicle #1 stated he was traveling behind Vehicle #2 on RT 88 prior to the crash. Driver #1 stated Vehicle #2 stopped on RT 88 at the entrance to Ocean Medical Center. Driver #1 stated he applied his brakes to stop but hydroplaned forward. It should be noted it had rained earlier and the ground was wet. Driver #1 stated he attempted to swerve to the right to avoid the crash but was unsuccessful. As a result Vehicle #1 collided with Vehicle #2 in a rear end crash. Vehicle #1 had minor driver side front end damage.

The driver of Vehicle #2 stated she was traveling eastbound on RT 88 prior to stopping at the entrance to Ocean Medical Center. Driver #2 stated while at a complete stop Vehicle #1 struck her vehicle along the rear end. Vehicle #2 had minor damage along the passengers rear side.

Based on my observations and statements made by both parties I found the driver of Vehicle #1 at fault for the crash.

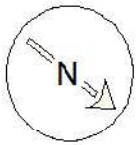

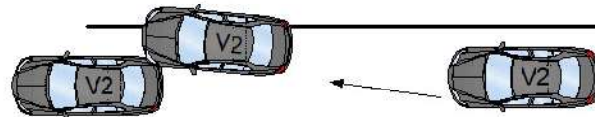
144 Crash Diagram (NOT TO SCALE)
