145. Crash Description/Narrative

A two car, rear-end, motor vehicle crash occurred on Rt. 88 east bound approximately 150 feet from Jack Martin Blvd. There were no reported injuries on scene. Both vehicles were able to safely be driven away from the scene.

This reaching motion caused her foot to come off of the brake pedal. Her car then crashed into the rear of vehicle 2.

His vehicle was stopped in traffic on Rt.88 for the light for Jack Martin Blvd. While stopped in traffic vehicle 1 crashed into the rear of his vehicle. He did not recall whether or not vehicle 1 was stopped behind him prior to

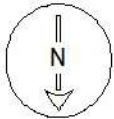
