145. Crash Description/Narrative

Vehicle 1 was attempting to pull into the Pick up / Drop off lane at the Complete Care Center (475 Jack Martin Blvd). Vehicle 1 struck the top of the entrance of the building, damaging the frame and the roof. Vehicle 1 received moderate damage to the roof of its vehicle.

Driver of Vehicle 1 stated he was attempting to pull into the Drop off lane. Driver 1 stated he miscalculated the height of his vehicle and the height of the roof. Driver 1 stated he struck the roof with his vehicle.

From my investigation, I find Driver of Vehicle 1 at fault for the crash. Driver 1 was issued summons: E21000076 (Careless Driving).

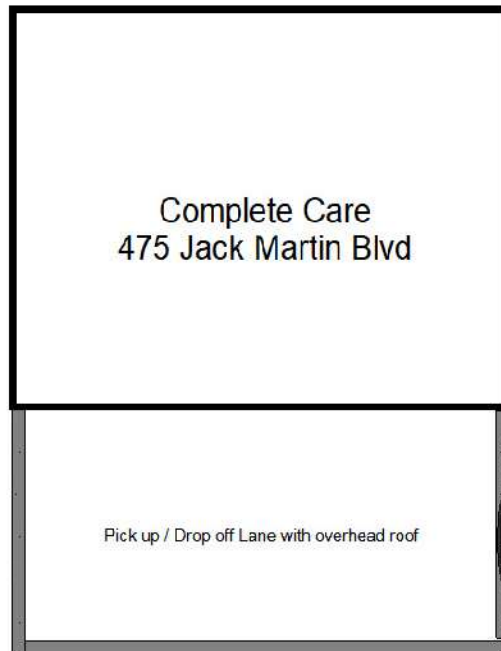
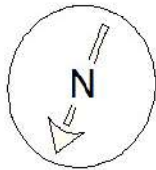
