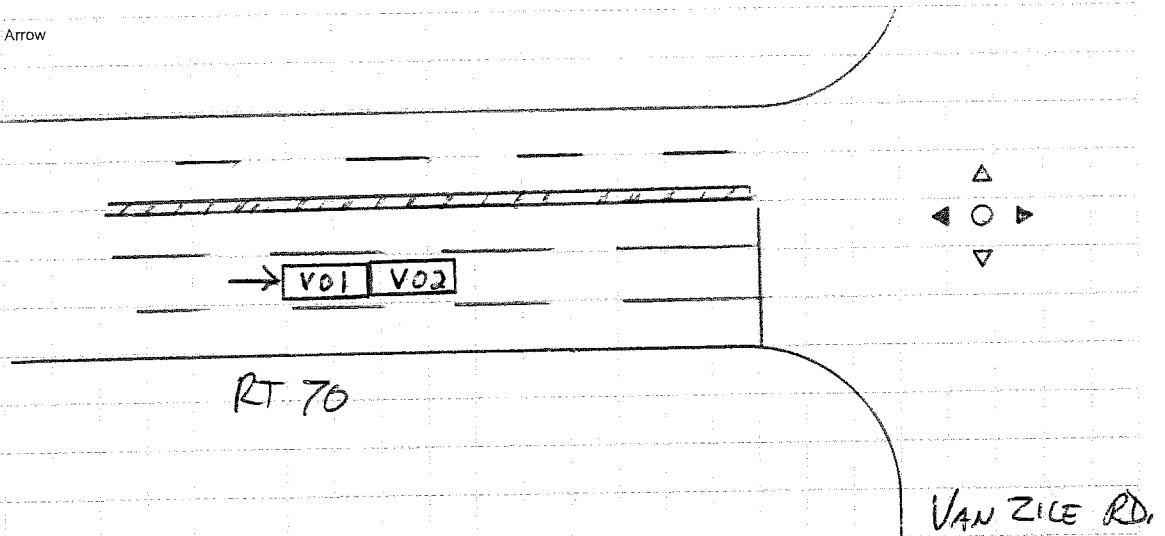

VEHICLE 01 STRUCK THE REAR OF VEHICLE 02 ON RT 70 EAST APPROXIMATELY 50' WEST OF VAN ZILE RD. IN THE CENTER LANE.

DRIVER OF VEHICLE 01 STATED HE WAS STOPPED IN THE CENTER LANE OF RT 70 EAST SEVERAL CARS BACK FROM THE LIGHT OF VAN ZILE RD. WHEN HE ROLLED INTO THE BACK OF VEHICLE 02.

DRIVER OF VEHICLE 02 STATED HE WAS STOPPED IN THE CENTER LANE OF RT 70 EAST SEVERAL VEHICLES BACK FROM THE RED SIGNAL OF VAN ZILE RD. WHEN HE WAS STRUCK FROM BEHIND BY VEHICLE 01.
