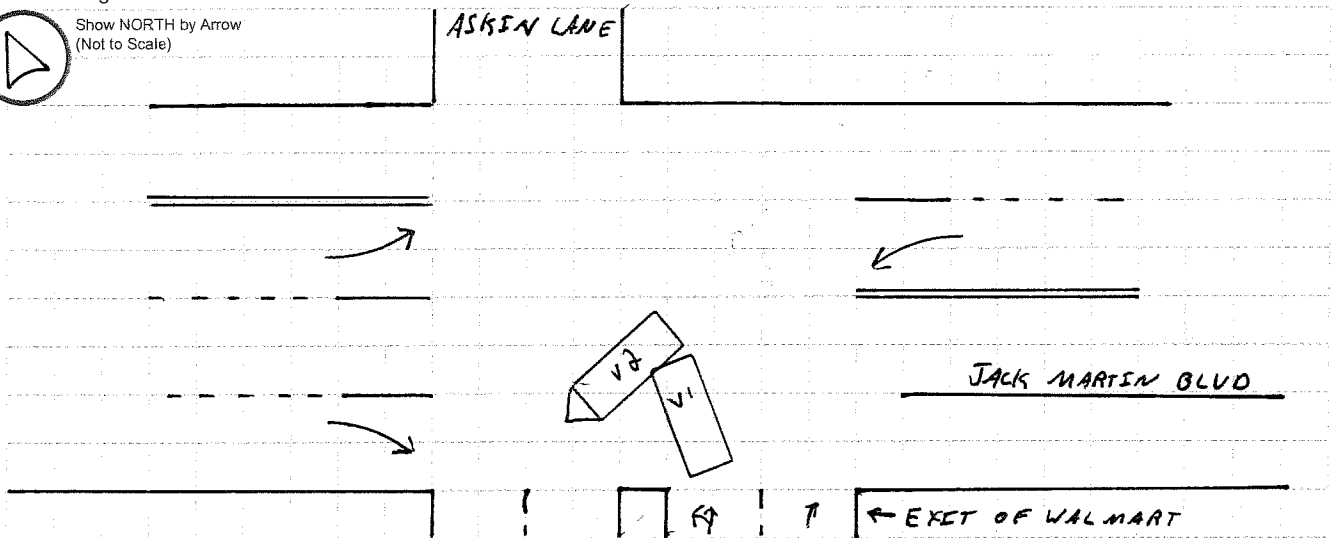

145. Crash Description/Narrative

VEHICLE #1 WAS STOPPED AT A MARKED STOP SIGN ATTEMPTING TO MAKE A LEFT TURN TO EXIT THE WALMART PARKING LOT. VEHICLE #2 WAS TRAVELING WEST ON JACK MARTIN BLVD ATTEMPTING TO MAKE A LEFT INTO THE WALMART PARKING LOT. VEHICLE #1 THEN PROCEEDED TO MAKE THE LEFT TURN DIRECTLY INTO THE SIDE OF VEHICLE #2. VEHICLE #1 FAILED TO OBSERVE VEHICLE #2 AND IS AT FAULT FOR THE MVA. BOTH VEHICLES WERE DAMAGED AND TOWED FROM THE SCENE. NO INJURIES WERE REPORTED. THE DRIVER OF VEHICLE #1 STATED THAT SHE NEVER SAW VEHICLE #2 AS SHE MADE THE LEFT TURN.
