145. Crash Description/Narrative

Driver of V1 stated she was stopped waiting to exit the parking lot of 7-11 onto Rt. 88 eastbound when V2 which was in front of her began to reverse. Driver of V1 stated she honked her horn multiple times but V2 continued to back up. V2 then crashed into V1. After the crash V2 fled the scene.

V2 was described as an older model red SUV with a spare tire on the tailgate, possibly a Honda CR-V or Toyota Rav4. A check of the area was negative for that vehicle.

Based on my investigation and observations on scene I determined V2 to be at fault for the motor vehicle crash.
