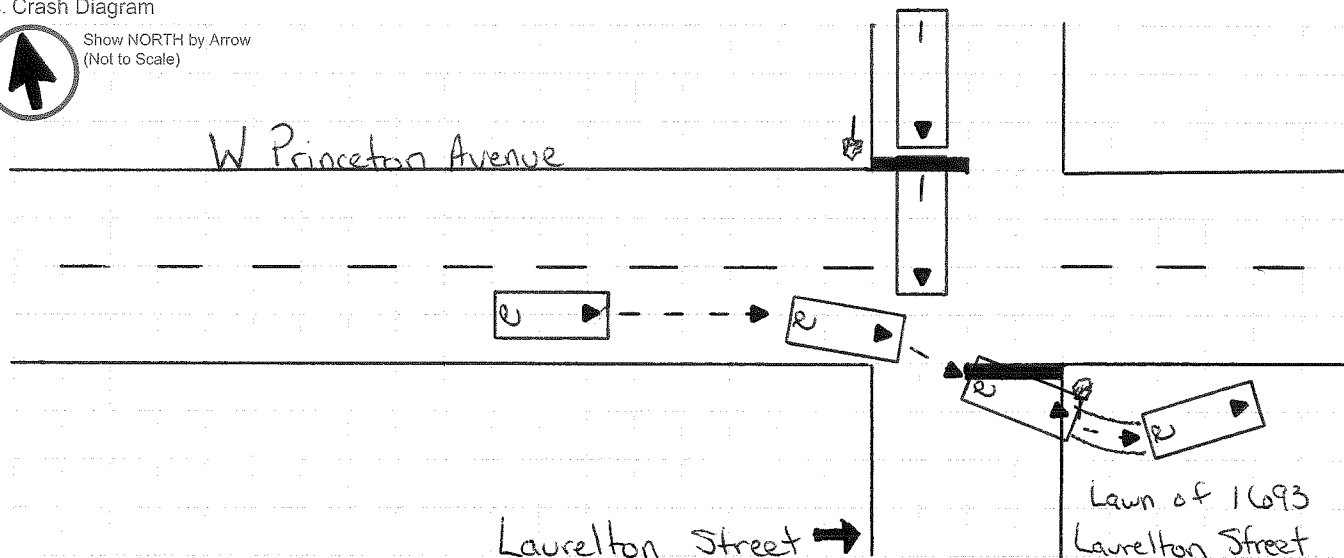

145. Crash Description/Narrative

Investigation at the scene indicated the following: Vehicle 2 traveled east on W Princeton Ave in the area of Laurelton St. As vehicle 2 approached Laurelton St, vehicle 1 failed to stop at a stop sign, and began to cross over W Princeton Ave. Vehicle 1's actions caused vehicle 2 to drive off the roadway to the right, jump a curb, strike a stop sign and came to a final rest on the lawn of 1693 Laurelton St. The lawn of 1693 Laurelton St was torn up by vehicle 2.

Driver 1 stated that he did not blow through the stop sign. Driver 1 was scared so he left the scene prior to police arrival but a witness followed him, so he returned to the scene.

Driver 2 stated that she traveled on W Princeton Ave and vehicle 1 blew through the stop sign. Vehicle 1's actions caused her to turn her vehicle to the right so she could avoid a collision. Her vehicle jumped a curb and struck a stop sign as she drove on 1693 Laurelton St's lawn.
