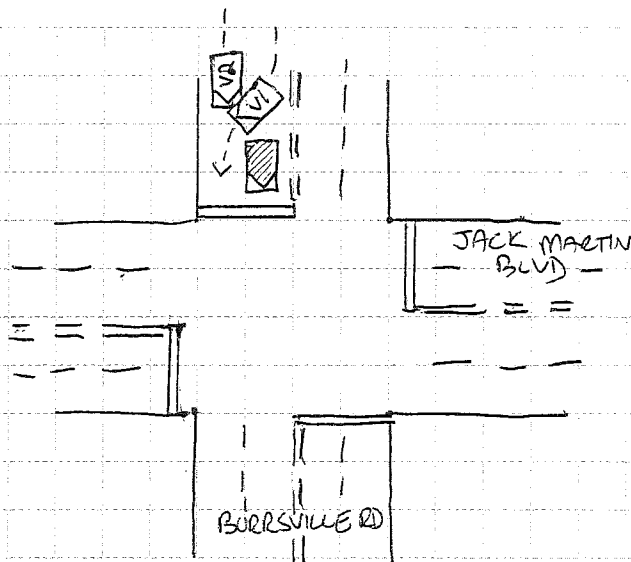

145. Crash Description/Narrative

V2 WAS TRAVELING SOUTH ON BURRSVILLE RD, HEADING TOWARDS THE GREEN-LIT INTERSECTION WITH JACK MARTIN BLVD, IN THE RIGHT-HAND LANE.

V1 WAS STOPPED BEHIND AN UNINVOLVED VEHICLE THAT WAS TURNING LEFT ONTO JACK MARTIN BLVD, IN THE LEFT LANE.

V1 ATTEMPTED TO PASS AROUND THE STOPPED VEHICLE AND ENTERED THE RIGHT LANE AS V2 PASSED BY. THE FRONT RIGHT OF V1 STRUCK THE FRONT LEFT OF V2 CAUSING MINOR DAMAGE TO EACH.
