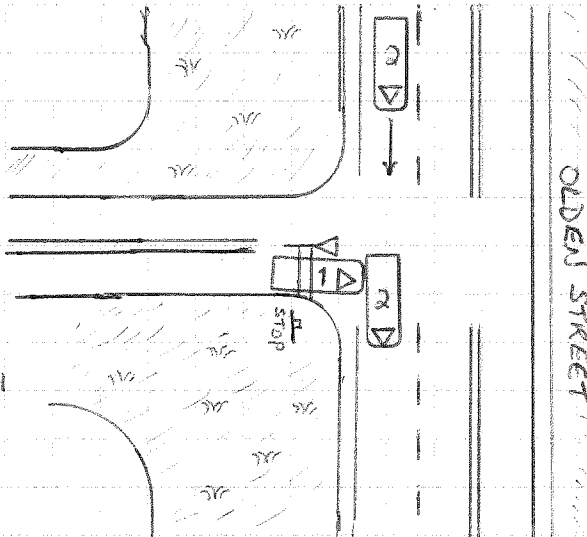

145. Crash Description/Narrative

VEHICLE 1 WAS EXITING THE PARKING LOT OF THE HOME DEPOT LOCATED AT 1722 RT 88 IN BRICK, NJ. VEHICLE 2 WAS TRAVELING SOUTH ON OLDEN STREET IN THE RIGHT LANE.

AS VEHICLE 1 EMERGED FROM THE EXIT, THE FRONT OF VEHICLE 1 STRUCK THE RIGHT REAR OF VEHICLE 2.

DRIVER OF VEHICLE 1 STATED THAT AFTER STOPPING FOR THE STOP SIGN, HE LOOKED BOTH DIRECTIONS BUT DID NOT SEE VEHICLE 2 APPROACHING.

OFFICER'S INVESTIGATION AT THE SCENE NOTED AN EXTREMELY BRIGHT SUN, LOW IN A CLEAR SKY, WHICH ALSO CONTRIBUTED TO THE DRIVER OF VEHICLE 1 NOT DETECTING VEHICLE 2.

NO INJURIES WERE REPORTED. NO MOTOR VEHICLE SUMMONSES ISSUED. BOTH VEHICLES WERE DRIVEN FROM THE SCENE.
