145. Crash Description/Narrative

VEHICLES 1 AND 2 WERE TRAVELING NORTHBOUND ON VAN ZILE ROAD APPROACHING THE INTERSECTION OF STATE HIGHWAY 70. VEHICLE 1 WAS IN THE LEFT LANE. VEHICLE 2 WAS IN THE RIGHT LANE.

DRIVER OF VEHICLE 1 STATED THAT AT SOME POINT PRIOR TO THE INTERSECTION, SHE ENCROACHED INTO VEHICLE 2'S LANE OF TRAVEL AND SIDE-SWIPE VEHICLE 2.

COSMETIC DAMAGE OCCURRED TO BOTH VEHICLES, BUT THEY WERE BOTH ABLE TO BE DRIVEN FROM THE SCENE. NO INJURIES WERE REPORTED. NO MOTOR VEHICLE SUMMONSES WERE ISSUED.
