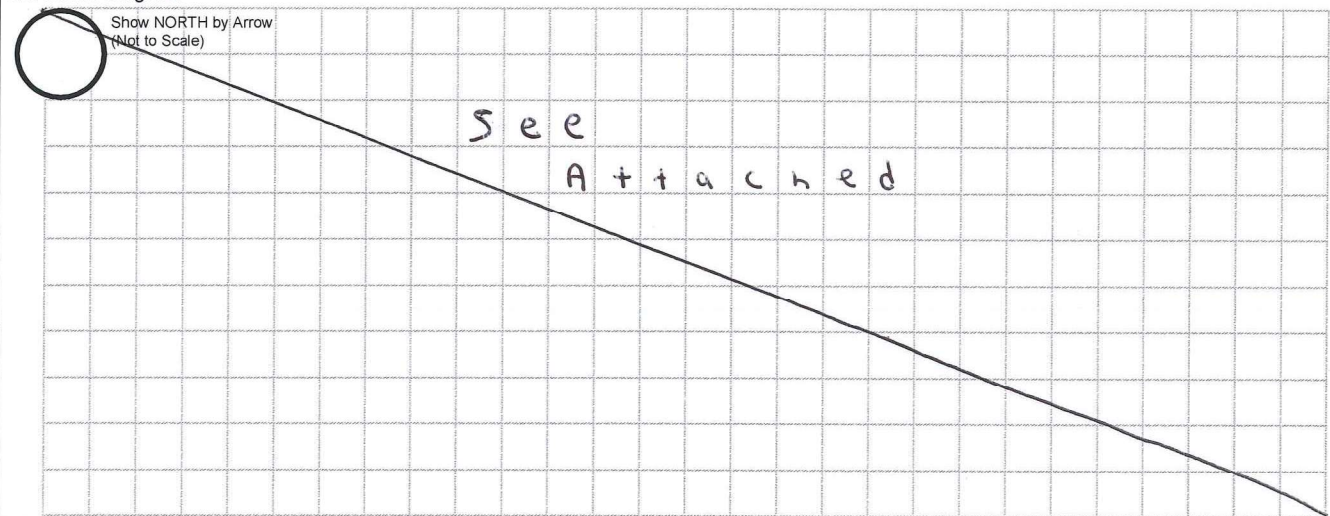

145. Crash Description/Narrative

On 04/28/2017 I responded to a two car motor vehicle crash that occurred on Route 88 West, approximately ten feet from the intersection of Post Road. Driver of Vehicle #1 was approaching the intersection of Route 88 and Post Rd and Driver of Vehicle #2 was stopped in traffic awaiting to turn left onto Post Rd. Driver #2 failed to observe Vehicle #1 stopped in traffic, subsequently causing the driver to strike Vehicle #2 from behind.

Driver of Vehicle #1 stated he failed to observe Vehicle #2 in time and when he attempted to stop it was too late.

Driver of Vehicle #2 stated he was stopped in traffic awaiting to turn when he was struck behind by Vehicle #1.

Brick Police EMS responded to the scene for a complaint of neck and back pain for the rear passenger of Vehicle #2. The passenger was subsequently transported to Ocean Medical Center.

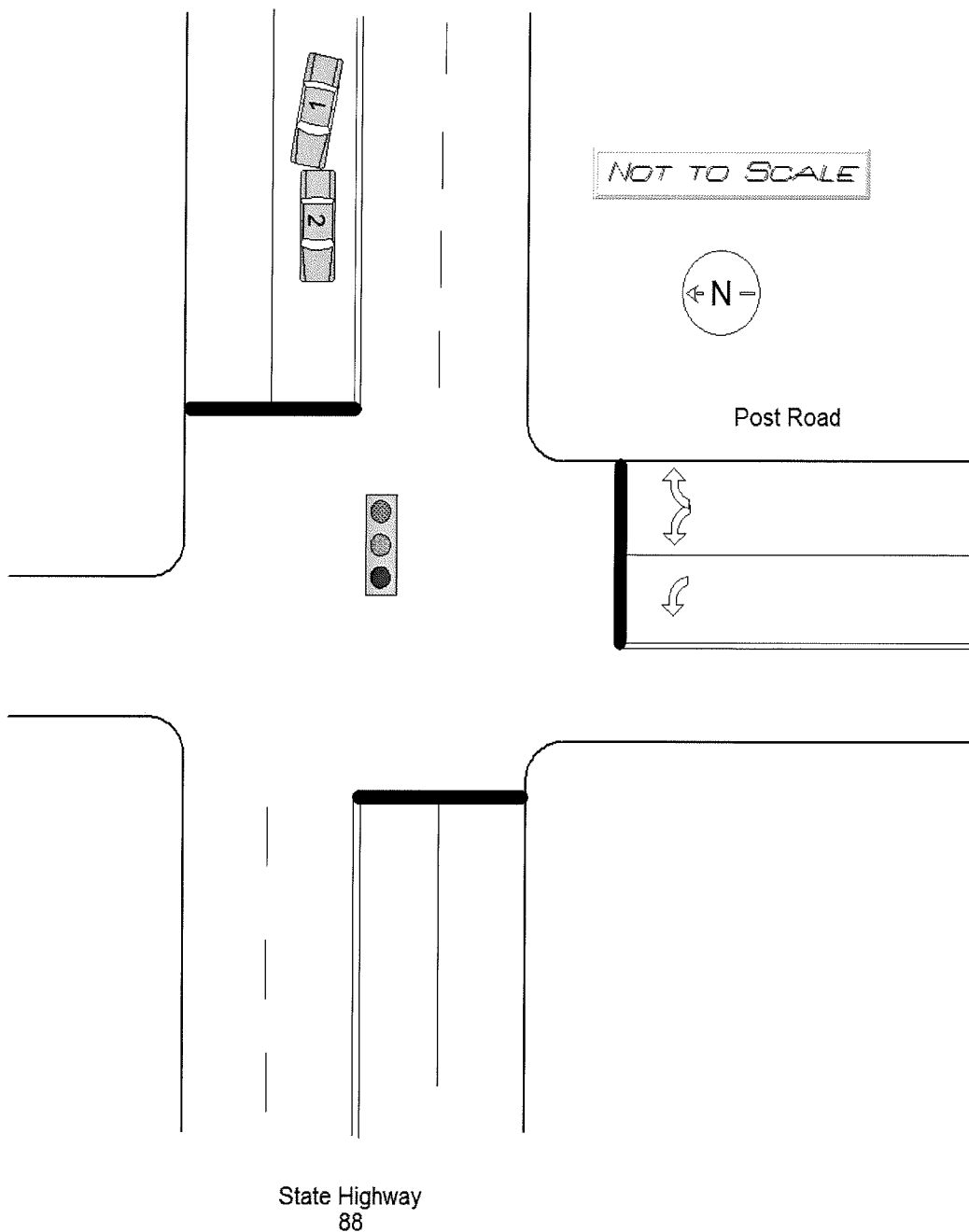
