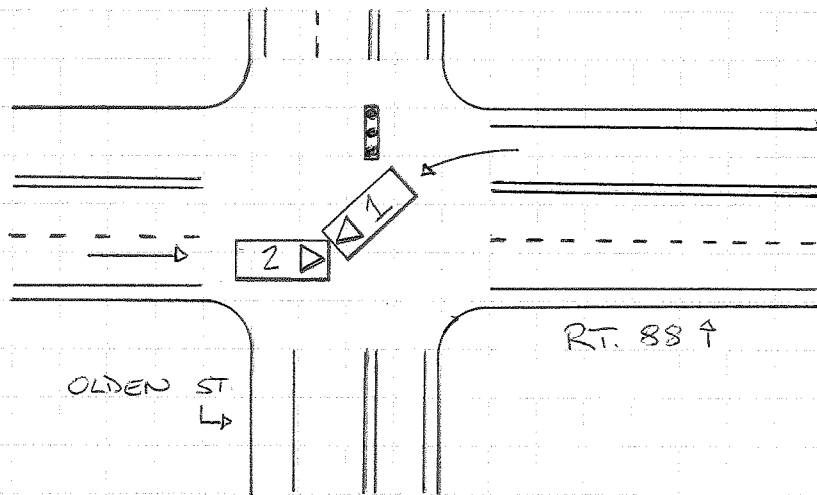

145. Crash Description/Narrative

VEHICLE 1 WEST ON ROUTE 88 ATTEMPTING TO TURN LEFT ONTO OLDEN STREET STRUCK VEHICLE 2 WHICH WAS TRAVELING EAST ON ROUTE 88 STRAIGHT THROUGH THE INTERSECTION.

DRIVER 1 STATED THERE WAS A PICKUP TRUCK TRAVELING IN THE OPPOSITE DIRECTION TURNING LEFT ONTO OLDEN STREET AND HE WAS UNABLE TO SEE VEHICLE 2 DUE TO THIS. WHEN VEHICLE 1 ATTEMPTED TO TURN HE STRUCK VEHICLE 2 WITHIN THE INTERSECTION.

DRIVER 2 STATED SHE WAS EAST ON ROUTE 88 BEHIND A PICKUP TRUCK IN THE LEFT LANE. WHEN THE PICKUP TRUCK TURNED ON ITS LEFT DIRECTIONAL DRIVER 2 MOVED INTO THE RIGHT LANE TO PROCEED STRAIGHT THROUGH THE INTERSECTION. WHEN VEHICLE 2 ENTERED THE INTERSECTION IT WAS STRUCK BY VEHICLE 1.

INVESTIGATION REVEALED THE CAUSE OF THE CRASH WAS DUE TO DRIVER 1'S INATTENTION TO INCOMING TRAFFIC.
