145. Crash Description/Narrative

Crash occurred on Jack Martin Blvd northbound, approximately 100 feet north of Frank Ave. Driver #2 stated he was stopped for traffic waiting to turn left into the Kinetic Medical Park when he was struck from behind by vehicle #1. Driver #1 stated she was traveling north on Jack Martin Blvd. She advised she did not see vehicle #2 was stopped until it was too late. She stated she tried to stop, but couldn't and subsequently struck the rear of veh #2. Driver #1 had a bloody nose from the airbag deployment. She was treated on scene by first aid, but refused further medical attention. Driver #2 was not injured. The passenger in vehicle #2 had complaint of lower back pain. She was treated on scene by first aid, but refused further medical attention. Driver #1 is at fault for driver inattention and was issued summons #: T154932 for Careless Driving, 39:4-97.
