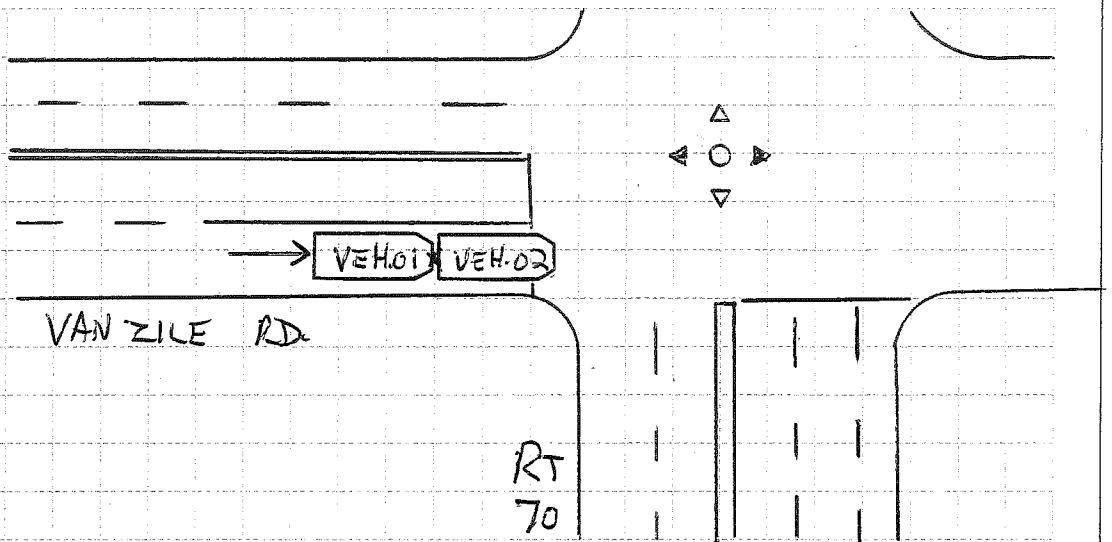

145. Crash Description/Narrative

VEHICLE 01 STRUCK THE REAR OF VEHICLE 02 WHILE TRAVELING SOUTH ON VAN ZILE RD. PRIOR TO THE INTERSECTION OF RT 70.

DRIVER OF VEHICLE 01 STATED SHE WAS STOPPED BEHIND VEHICLE 02 ON VAN ZILE RD. SOUTH IN THE RIGHT LANE WHEN SHE THOUGHT VEHICLE 02 MADE A RIGHT TURN ONTO RT 70 WEST. VEHICLE 01 THEN PROCEEDED FORWARD STRIKING THE REAR OF VEHICLE 02. DRIVER OF VEHICLE 02 STATED WHILE STOPPED IN THE RIGHT LANE OF VAN ZILE RD. SOUTH AT A RED LIGHT WAITING TO MAKE A RIGHT TURN SHE WAS STRUCK IN THE REAR BY VEHICLE 01.
