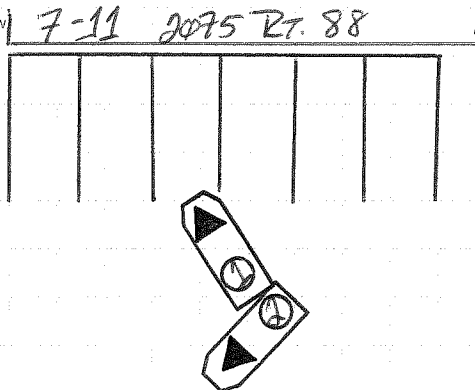

VEHICLE 2 STARTING TO MERGE ONTO RT. 88 EASTBOUND FROM THE PARKING LOT OF 7-11, 2075 RT. 88. VEHICLE 1 BACKING OUT OF A PARKING SPACE IN THE PARKING LOT OF 7-11, 2075 RT. 88.

DRIVER 2 STATED SHE WAS JUST STARTING TO ACCELERATE WHEN SHE WAS STRUCK BY VEHICLE 1. DRIVER 1 STATED HE WAS BACKING OUT OF A PARKING SPACE AND NEVER SAW VEHICLE 2 UNTIL AFTER HE STRUCK IT.

A PASSENGER IN VEHICLE 2 HAD BACK PAIN. DRIVER 2 STATED HER PASSENGER HAS A HISTORY OF BAD BACK PROBLEMS.
