145. Crash Description/Narrative

Vehicle 1 was traveling west on Rt 70. Vehicle 2 was also traveling west in front of vehicle 1. Vehicle 2 came to a stop at the light of Rt 70 and Olden St. The crash occurred when vehicle 1 failed to brake in time, crashing into vehicle 2.

Driver 2 advised she was waiting at the light on Rt 70 and Olden. Driver 1 stated he failed to brake in time.

Investigation at the scene determined Driver 1 was at fault and issued one summons for 39:4-97.
