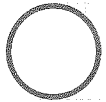

145. Crash Description/Narrative

V#1 and V#2 were traveling in the Brick Hospital parking lot, 425 Jack Martin Blvd. V#1 stopped at a stop sign and V#2 stopped to the rear of V#1. V#1 backed up due to another car pulling out of a parking stall. V#1 backed into V#2.

Driver of V#1 advised he backed up in the Brick Hospital parking lot due to another vehicle exiting a parking stall. Driver of V#1 stated he backed into V#2.

Driver of V#2 was the valet at Brick Hospital. Driver of V#2 advised he was stopped to the rear of V#1 when V#1 backed up into his vehicle.

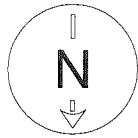
