145. Crash Description/Narrative

VEHICLE 1 WAS TRAVELING WEST IN THE PARKING LOT OF 1899 RT 88. VEHICLE 2 WAS TRAVELING NORTH ON BARB LANE. AS VEHICLE 1 EXITED THE PARKING LOT ONTO BARB LANE, VEHICLE 1'S FRONT BUMPER STRUCK VEHICLE 2'S RIGHT FENDER.

DRIVER OF VEHICLE 1 STATED AS HE EXITED THE PARKING LOT ONTO BARB LANE, HE CRASHED INTO VEHICLE 2. DRIVER OF VEHICLE 1 STATED THE SUN WAS IN HIS EYES AND A TREE OBSTRUCTED HIS VIEW OF VEHICLE 2. DRIVER OF VEHICLE 1 STATED HE DID NOT OBSERVE VEHICLE 2 UNTIL THEY CRASHED.

DRIVER OF VEHICLE 2 STATED HE WAS TRAVELING NORTH ON BARB LANE APPROACHING RT 88. DRIVER OF VEHICLE 2 STATED VEHICLE 1 EXITED THE PARKING LOT AND CRASHED INTO HIM.
