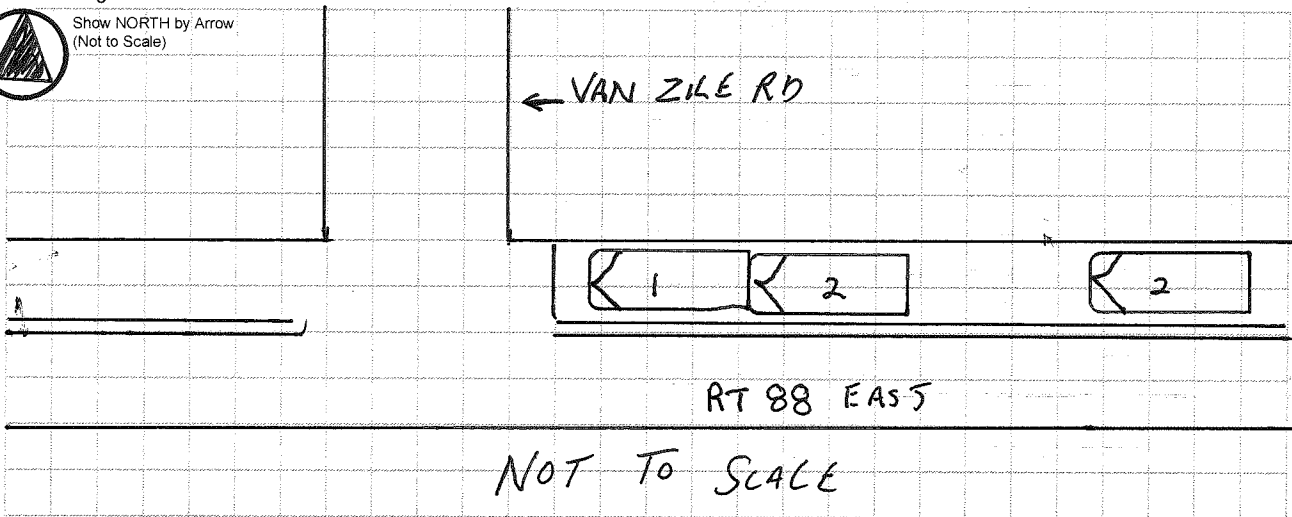

145. Crash Description/Narrative

Vehicles #1 and #2 were traveling westbound on Rt 88 East. Vehicle #1 stopped for the red traffic signal at Van Zile Rd and Vehicle #2 collided into the rear of vehicle #1.

Driver #1 stated that she stopped for the red traffic light and vehicle #2 collided into the rear of her vehicle. Driver #2 stated that vehicle #1 slammed on her brakes to stop for the red traffic signal and he collided into vehicle #1.
