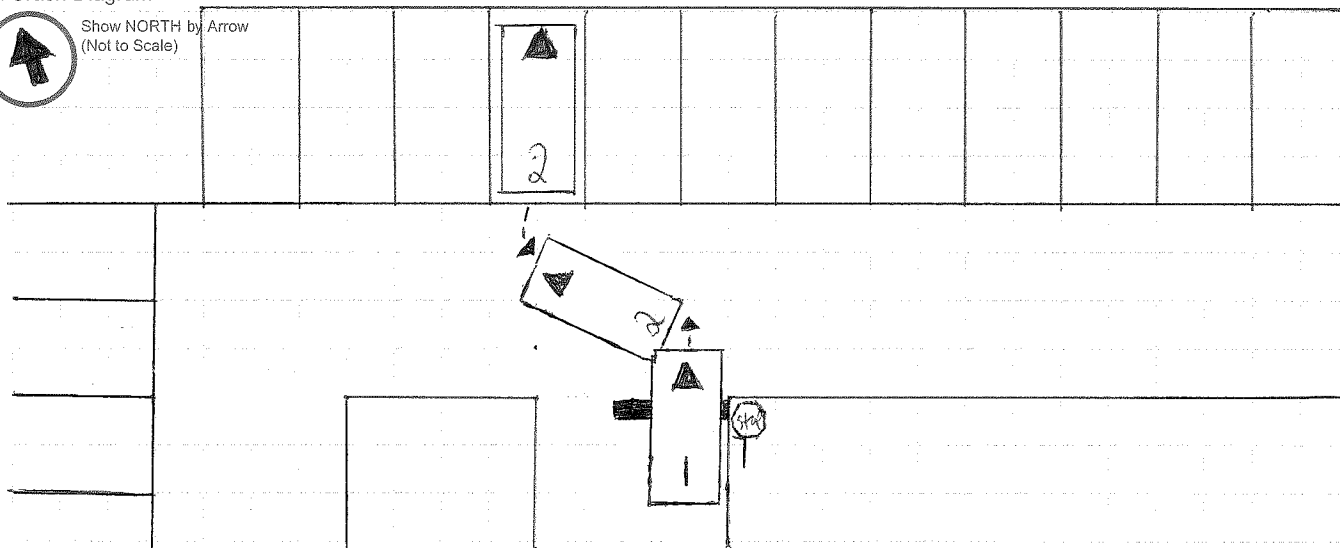

145. Crash Description/Narrative

Investigation at the scene indicated the following: Vehicle 2 backed from a parking space in the parking lot of 1640 Route 88 and vehicle 1 was also in the same parking lot while stopped at a stop sign. As vehicle 2 backed vehicle 1 attempted to make a left turn. Both vehicles struck each other while at the intersection.

Driver 1 stated the following: Driver 1 was stopped at the stop sign, and she began to inch up to see if there was vehicles to her right. Vehicle II suddenly reversed into the front of Driver 1's vehicle.

Driver 2 Stated the following: Driver 2 observed no vehicles behind her so she began to back out of her parking space. Vehicle 1 suddenly drove in to the rear of her vehicle. The driver of vehicle 1 began to yell at her saying that it was her fault.
