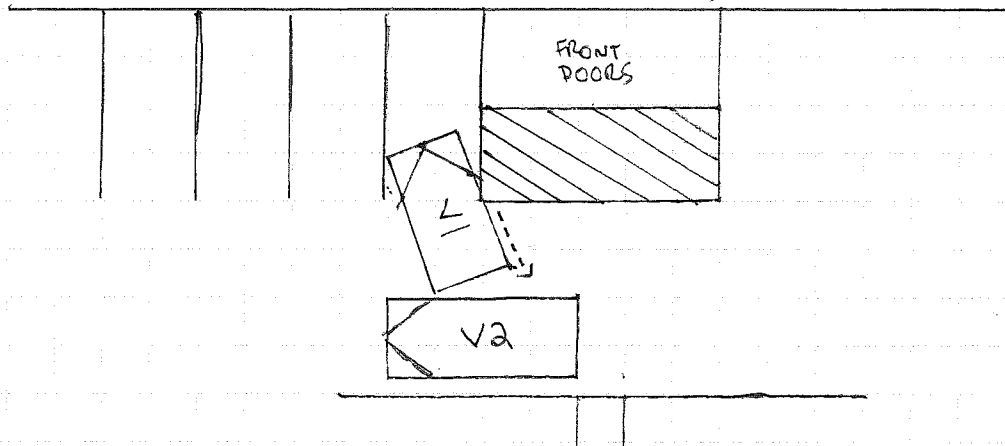

145. Crash Description/Narrative

V2 WAS AN ALERT AMBULANCE, PARKED ALONG A CURB TO UNLOAD A PATIENT AT 457 JACK MARTIN BLVD. THE PATIENT, CAROL LYNCH, WAS SEATED IN A WHEEL CHAIR AND SECURED IN THE REAR OF THE AMBULANCE. V1 BACKED OUT OF A PARKING SPACE, BUT DUE TO HEAVY SNOW FALL MISJUDGED THE DISTANCE TO V2. REAR OF V1 STRUCK THE SIDE OF V2, CAUSING NO DAMAGE TO EITHER VEHICLE. LYNCH HAD A COMPLAINT OF PAIN IN HER BACK AND LEGS AND WAS TRANSPORTED TO OCEAN MEDICAL CENTER IN A DIFFERENT AMBULANCE FOR TREATMENT.
