145. Crash Description/Narrative

Vehicle 01 was traveling east in the right lane on Burnt Tavern Road. Vehicle 01 lost control of her vehicle and ran off the road making contact with a JCP&L pole (JC62408BK), and then left the scene.

A motorist called Brick Police dispatch and explained that a vehicle was parked facing the wrong way on Burnt Tavern Road. Brick Police dispatch dispatched Ptl. Valeri #244 at that time. The caller reported that the vehicle, a red or orange challenger, turned onto Van Zile Road with left front damage. Ptl. Valeri was not able to locate the vehicle. Reference case number: 17-13035.

At 2356 hours a second caller called Brick Police Dispatch reporting that the Green Briar traffic Light not cycling. Brick Police Dispatch dispatched Ptl. Therghesen #249. It was reported that the a JCP&L pole was struck approximately 200 feet from The Boulevard on the east bound side. Reference case number: 17-13040.

At 0105 hours, Point Pleasant Boro located the vehicle in their town at Pizza Express. I responded to the location and observed a red Dodge Challenger, matching the description of the above motor vehicle complaints, bearing NJ reg. U58GLW with front left damage. I also observed driver side airbag deployment.

On February 26, 2017, the driver of Vehicle #1 responded to Brick Headquarters and explained she was driving the vehicle when she crashed into the pole. She explained she was ran off the road from a unknown vehicle.
