No injuries were reported on scene. Vehicle 2 remained disabled on scene.

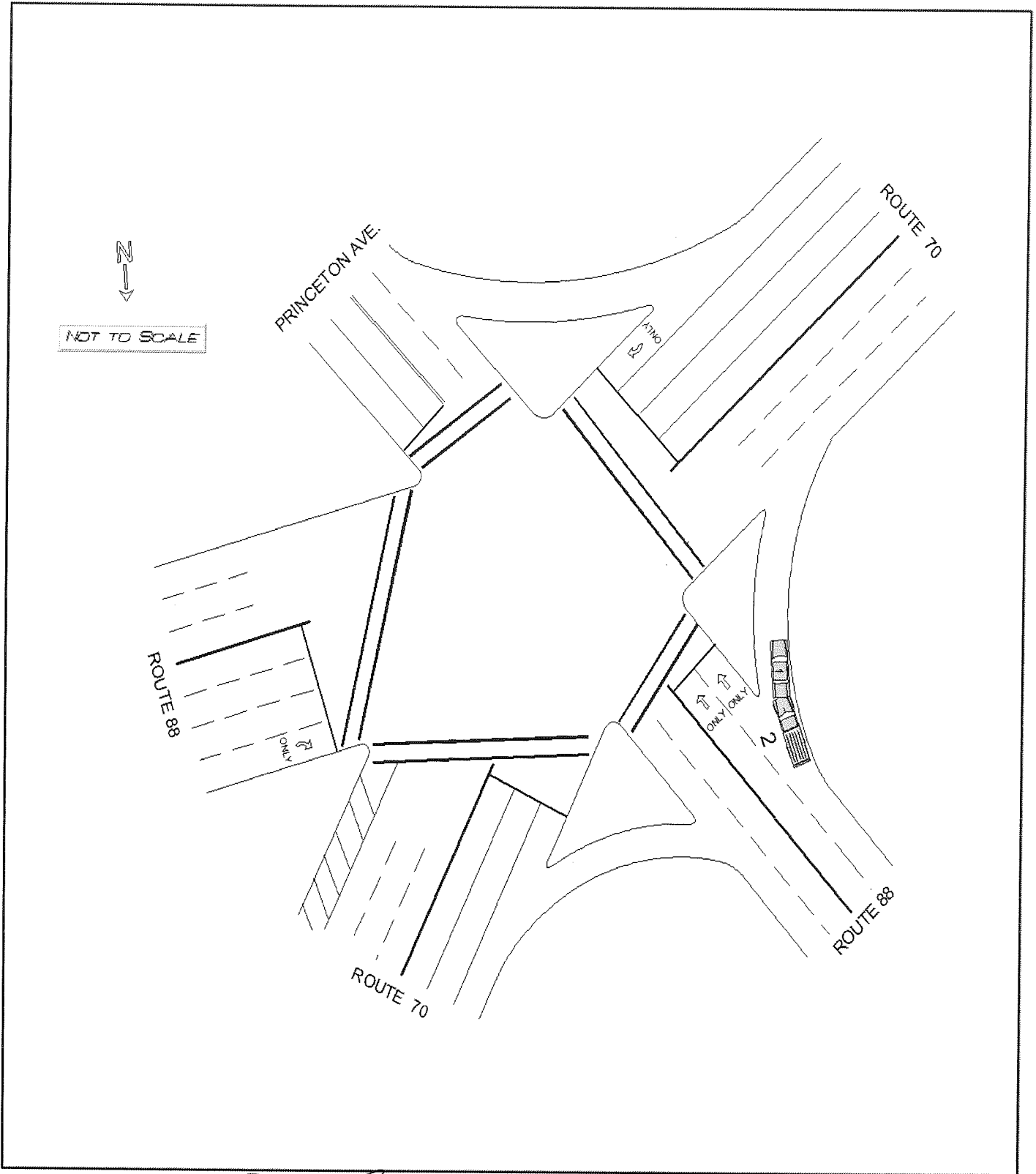
