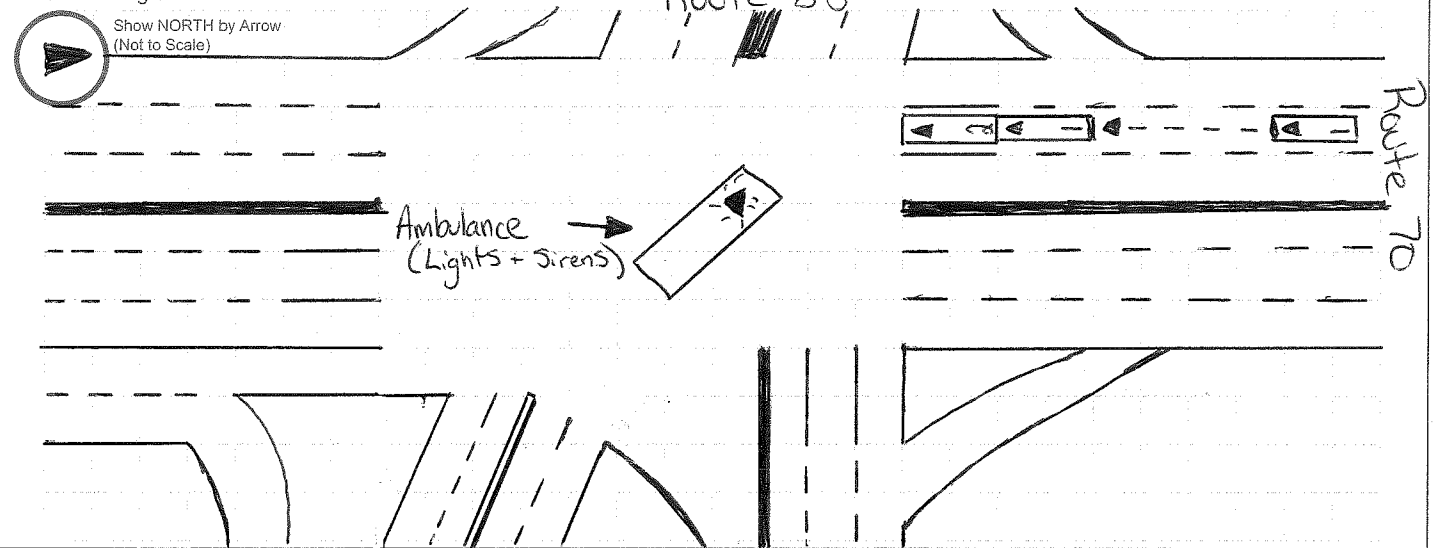

145. Crash Description/Narrative

Investigation at the scene indicated the following: Vehicle 2 traveled west on Route 70 in the center lane near the intersection with Route 88 and vehicle 1 was directly behind vehicle 2. Vehicle 2 stopped in traffic and yield the right away to an ambulance that had the emergency lights activated and sirens on. Vehicle 1 attempted to stop but slide do to wet road conditions. The front of vehicle 1 struck the rear of vehicle 2.

Driver 1 stated the following: Driver 1 saw the ambulance in the intersection and he also saw vehicle 2 stopped. Driver 1 attempted to stop his vehicle but it slid into the rear of vehicle 2 due to the wet roadway.

Driver 2 stated the following: Driver 2 was stopped in traffic due to an ambulance that crossed over the intersection. The rear of her vehicle was suddenly struck by vehicle 1. Driver 2 observed vehicle 1 attempt to stop as she looked in her rearview mirror.
