145. Crash Description/Narrative

Investigation at the scene revealed: Vehicle #01 was traveling East on Rt. 88 approximately 250 feet West of Pinewood Dr. when Vehicle #01 drove off the right side of the roadway. Vehicle #01 struck a Utility Pole (JC12BK), disabling it.

Driver #01 stated a deer ran out in front of his vehicle forcing him to swerve off the roadway. Passenger #02 stated she was not looking up and did not observe the accident.

Driver #01 was transported to Brick Hospital for cuts he sustained to his face and head, from his head smashing into the front windshield.

Joe's Service Center towed the disabled vehicle.
