145. Crash Description/Narrative

Vehicle 01 was at the first fuel stall at the Speedway Gas Station located at 1672 Route 88 and started to pull away. Vehicle 02 pulled into the parking lot of Speedway located at 1672 Route 88 and drove around the parking lot. As vehicle 02 was driving around vehicle 01, vehicle 01 began to pull away from the gas stall and struck vehicle 02 causing minor scrapes to the right front bumper of vehicle 01 and dented the left rear door of vehicle 02.

The driver of vehicle 01 stated she was pulling away from the gas stall and did not see vehicle 02 coming around the passenger side of her vehicle. The driver of vehicle 01 began to pull away from the gas stall she struck vehicle 02.

The driver of vehicle 02 stated he pulled into Speedway Gas Station and was looking for a available stall. The driver of vehicle 02 stated he approached vehicle 01 and passed on the passenger side and when he turned in front of vehicle 01 she pulled away and stuck his left rear door.
