145. Crash Description/Narrative

The driver of vehicle #2 stated he was traveling west on Rt 88 when vehicle #1 attempted to turn left out of the parking lot of 2138 Rt 88, directly in front of him.

The driver of vehicle #1 stated he was attempting to turn left from the parking lot of 2138 Rt. 88 on to Rt. 88 east. He stated he never observed vehicle #2 traveling west on Rt 88 and turned directly in front of him.

Based on the evidence as well as the drivers statements, it is my determination that the driver of vehicle #1 caused the crash by making an improper turn in front of vehicle #2.

Minor damage to both vehicles. No injuries reported.
