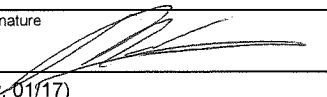
145. Crash Description/Narrative

Vehicle #1 northbound parking lot 425 Jack Martin Blvd. (Ocean Medical Center) going straight ahead struck pedestrian crossing the roadway. Pedestrian #1 crossing roadway from west to east was struck by vehicle #1. Driver #1 stated that she was preparing to make a left turn, looked down at her directional to engage it and when she looked up she had struck the pedestrian. Pedestrian #1 stated that he observed a vehicle traveling southbound without its headlamps on and waited for it to pass; after the vehicle passed he started to cross the street and heard the sound of a vehicle behind him and was struck by vehicle #1. Driver #1 failed to remain attentive while operating the vehicle and collided with a pedestrian that she did not observe in the roadway until it was too late to react. Pedestrian #1 entered the roadway without observing that traffic had stopped before crossing the roadway. Driver #1 stated that she did not have any injuries. I observed scratches on the driver's side of the hood to vehicle #1 where the vehicle impacted pedestrian #1. Pedestrian #1 had a complaint of pain to his right and left feet, lower back, and lower abdomen. Pedestrian #1 was transported to the Ocean Medical Center Emergency Room. The Ocean Medical Center Emergency Room staff stated that they did not believe that pedestrian had any injuries to any major organs and was being sent for evaluation at the time of this report was submitted.

At the time of the crash it was raining, dark, the street lights were on, and the roadway was wet. Pedestrian was wearing an orange rain jacket. Tiffany O'Dwyer stated that she observed the crash and completed a Brick Township Motor Vehicle Crash Statement Form. Her statement directly from the form reads: "Man was crossing road into Ocean Medical Center weather was dark raining woman hit man on accident". O'Dwyer indicated on the form that it was dark, raining, street lights on, and the headlamps were on for vehicle #1. The area pedestrian #1 chose to cross the street was not marked as a crosswalk and was approximately 20' south of an intersection with the parking lot access road and a parking lot.

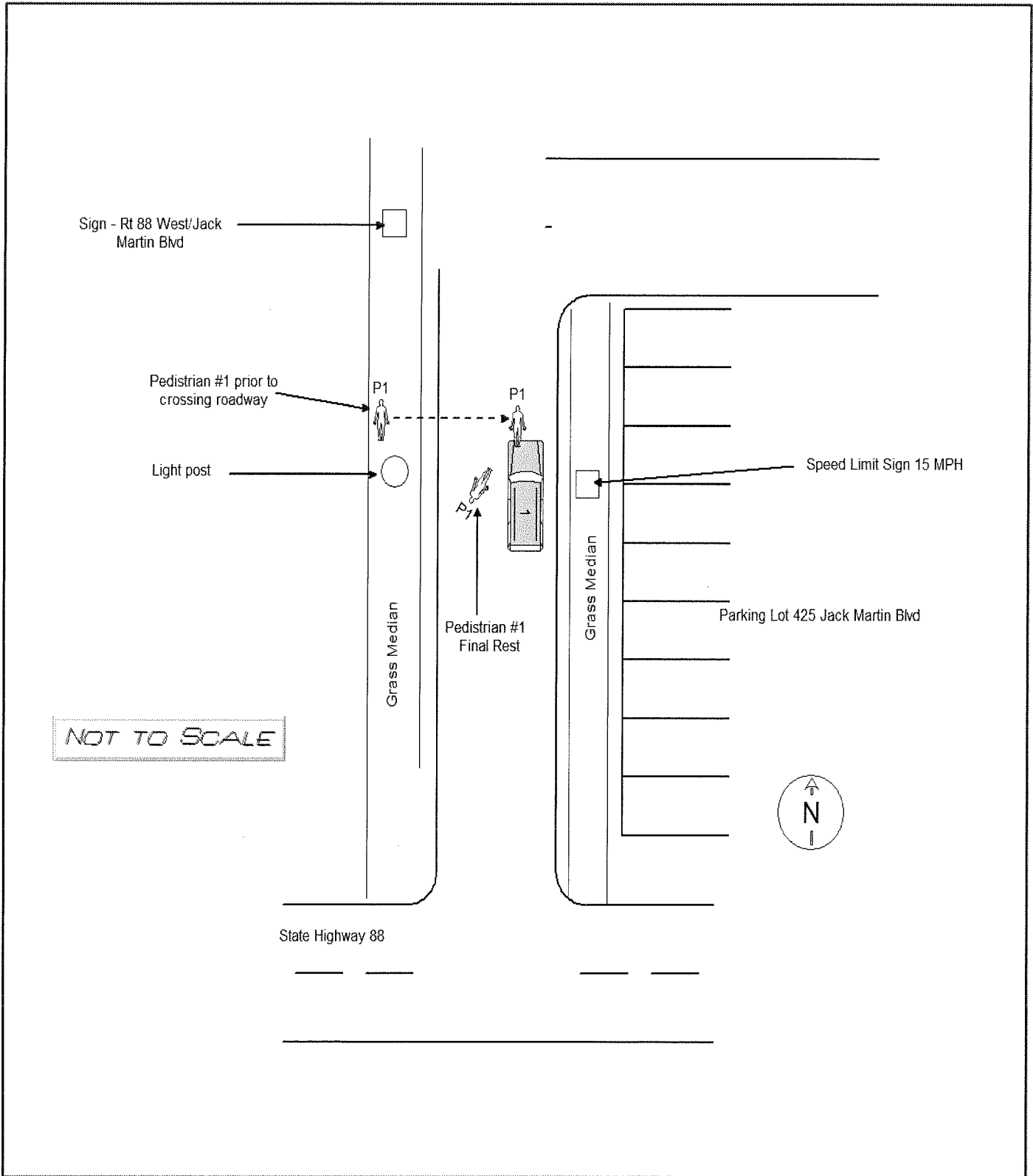
Driver #1 was issued a summons for 39:4-97, Careless Driving, 1506-E17-0043.
