145. Crash Description/Narrative

Vehicle #01 was traveling south on JACK MARTIN BLVD and was stopped to turn left into #446. Vehicle #02 was traveling south on JACK MARTIN BLVD, failed to stop and struck vehicle #01 in the rear bumper, with the front bumper of vehicle #02. The impact caused significant damage to both vehicles.

Driver #01 stated she was stopped and was struck from behind. Driver #02 stated he couldn't stop and struck vehicle #01.

No injuries were reported. Vehicle #01 was towed to D & L tow yard and vehicle #02 was towed to Surfside Collision, disabled.

Driver #02 was found to be unlicensed. He was issued motor vehicle summons #1506-T-152900 for carless driving, 39:4-97 and 1506-T-152901 for driving without a license, 39:3-10b.
