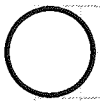

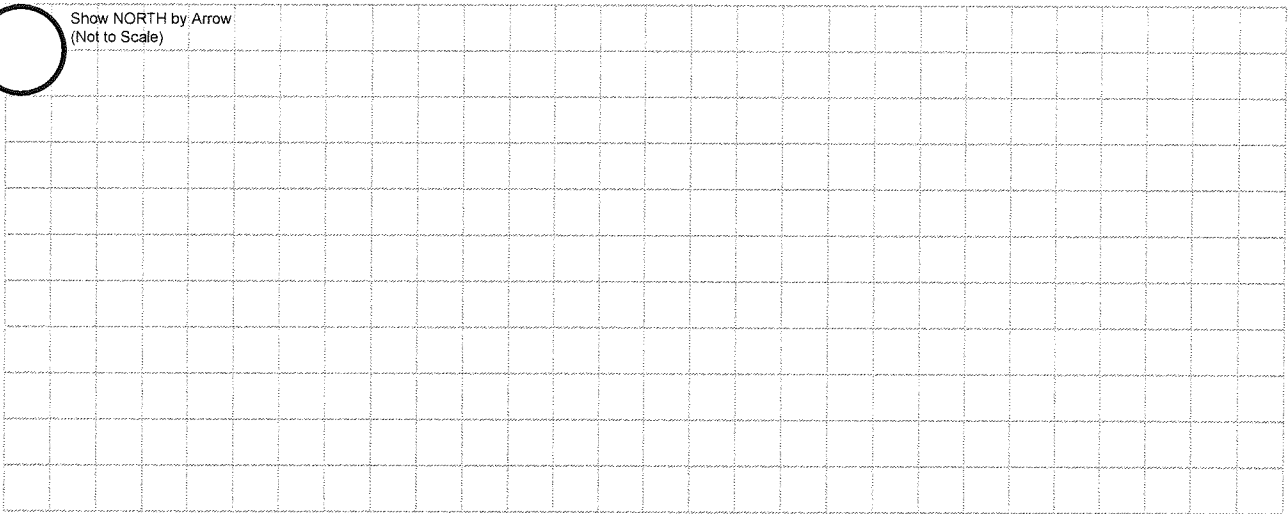

145. Crash Description/Narrative

My investigation revealed the following:

Vehicle 1 was stopped at a stop sign in the Walmart parking lot, 1872 RT 88. Pedestrian 1 was pushing a shopping cart across the parking lot in front of Vehicle 1. Driver 1 stated he looked both ways and proceeded to drive forward. When Vehicle 1 started to move he made contact with Pedestrian 1 causing pain to his hand.

Brick Police EMS responded to the scene to treat Pedestrian 1 who refused medical treatment and signed off with EMS.

Vehicle 1 sustained no damage and was driven from the scene.

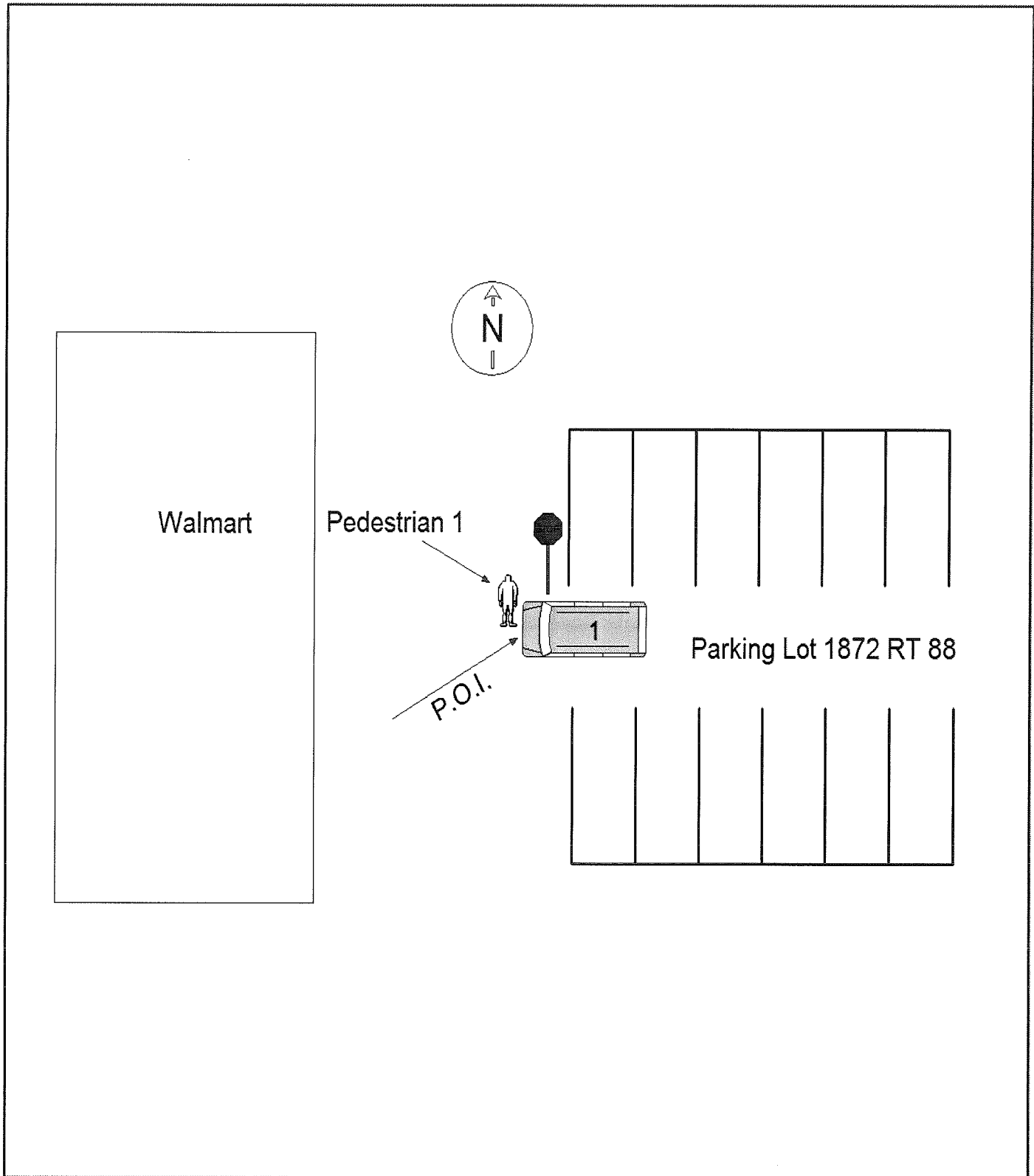
