VEHICLE 1 WAS BACKING OUT OF A PARKING STALL AT 3085 Rt 88.
VEHICLE 2 WAS PULLING INTO A PARKING STALL NEXT TO VEHICLE 1.
VEHICLE 1 STRUCK VEHICLE WHILE BACKING OUT OF THE STALL.

VEHICLE 1'S DRIVER STATED SHE DID NOT SEE VEHICLE 2 PULLING IN
AS SHE WAS BACKING OUT. VEHICLE 1 HAD MINOR DAMAGE TO THE REAR
DRIVERS SIDE BUMPER.

DRIVER OF VEHICLE 2 STATED SHE WAS PULLING INTO THE SPOT WHEN SHE
WAS STRUCK BY VEHICLE 1. VEHICLE 2 HAD MINOR DAMAGE TO THE
REAR PASSENGER SIDE QUARTER PANEL.

NO INJURIES WERE REPORTED AT THE SCENE. BOTH VEHICLES WERE

Motor Vehicle Crash Diagram

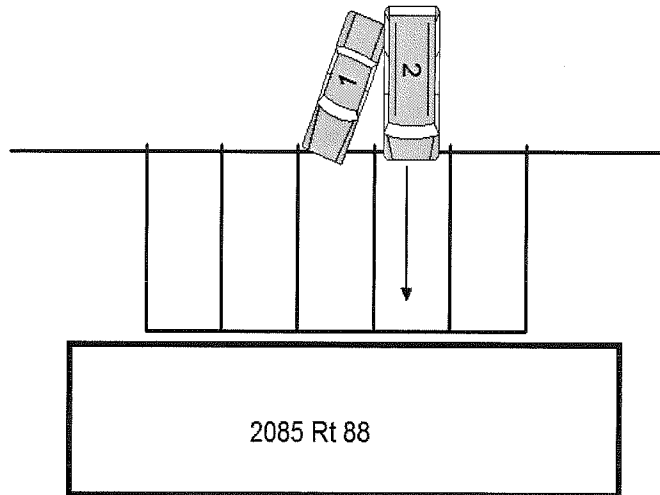
