145. Crash Description/Narrative

Vehicle #1 was traveling westbound on Route 88. Vehicle #2 was stopped on Route 88 awaiting eastbound traffic to turn left onto Midstreams Place. Vehicle #1 rear ended Vehicle #2.

Vehicle #1 operator stated he did not observe Vehicle #2 was stopped in the roadway while traveling on Route 88.

Vehicle #1 operator stated he stepped on the brakes and slid into Vehicle #2 due to wet road conditions.

Vehicle #2 operator stated he was stopped on Route 88, waiting to turn left onto Midstreams Place when he was forcefully rear ended by Vehicle #1. Vehicle #2 operator stated his left turn signal was activated.

Vehicle #2 operator had minor complaint of neck pain but refused EMS response. No other injuries were reported.

Vehicle #1 was partially disabled and moved off the roadway into a parking lot.

Investigation revealed Vehicle #1 operator caused the crash by not observing Vehicle #2 stopped in traffic on Route 88.

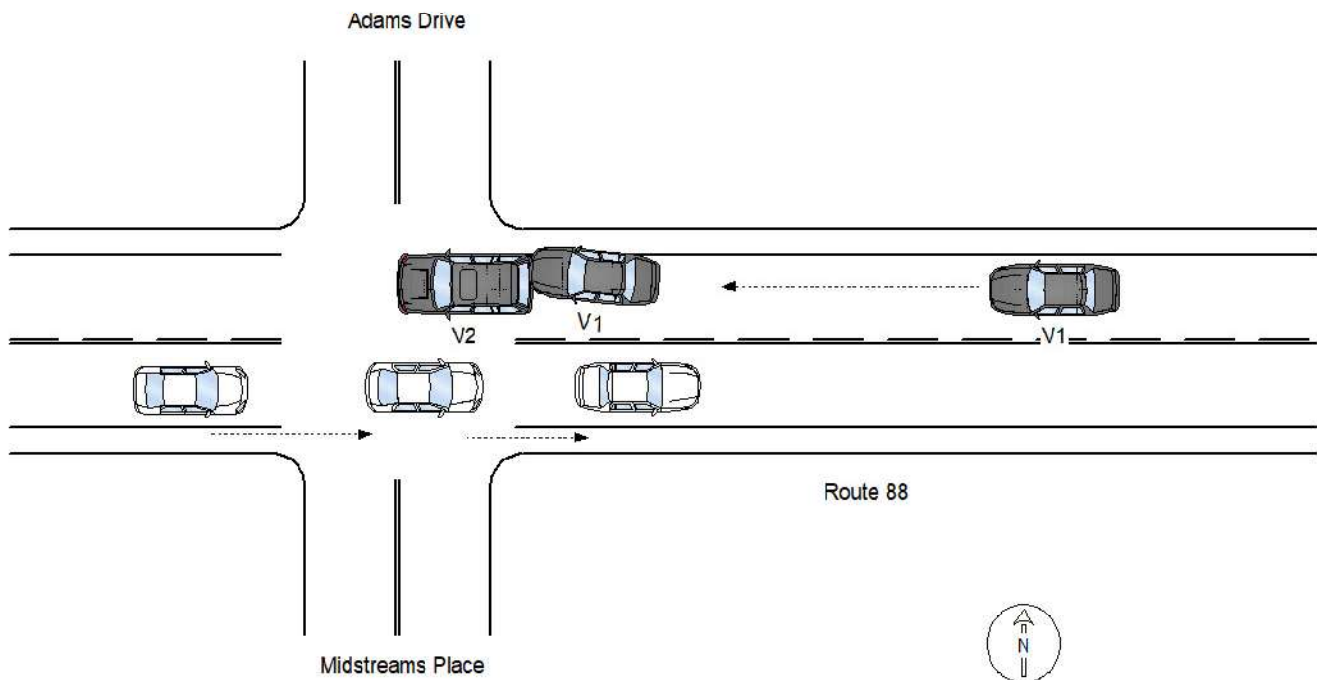
