145. Crash Description/Narrative

Investigation at the scene indicated the following: Vehicle 2 was stopped in traffic on Route 88 at the intersection with Fort Street. Vehicle 1 was directly behind vehicle 2, failed to stop and struck the rear passenger side of vehicle 2 with the front driver side of the vehicle.

Driver 1 stated the following:

She made a right turn out of a parking lot and looked into her rearview mirror incase any vehicles were close behind her and was not looking forward when the accident occurred. The front driver side of her vehicle struck the rear passenger side of vehicle 2. She believed vehicle 2 was stopped in the roadway to make a left turn onto Fort Street.

Driver 2 stated the following:

She was completely stopped in traffic on Route 88 to make a left turn onto Fort Street. The rear of her vehicle was suddenly struck by the front of vehicle 1. She was not injured; however, she claimed to be previously

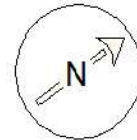
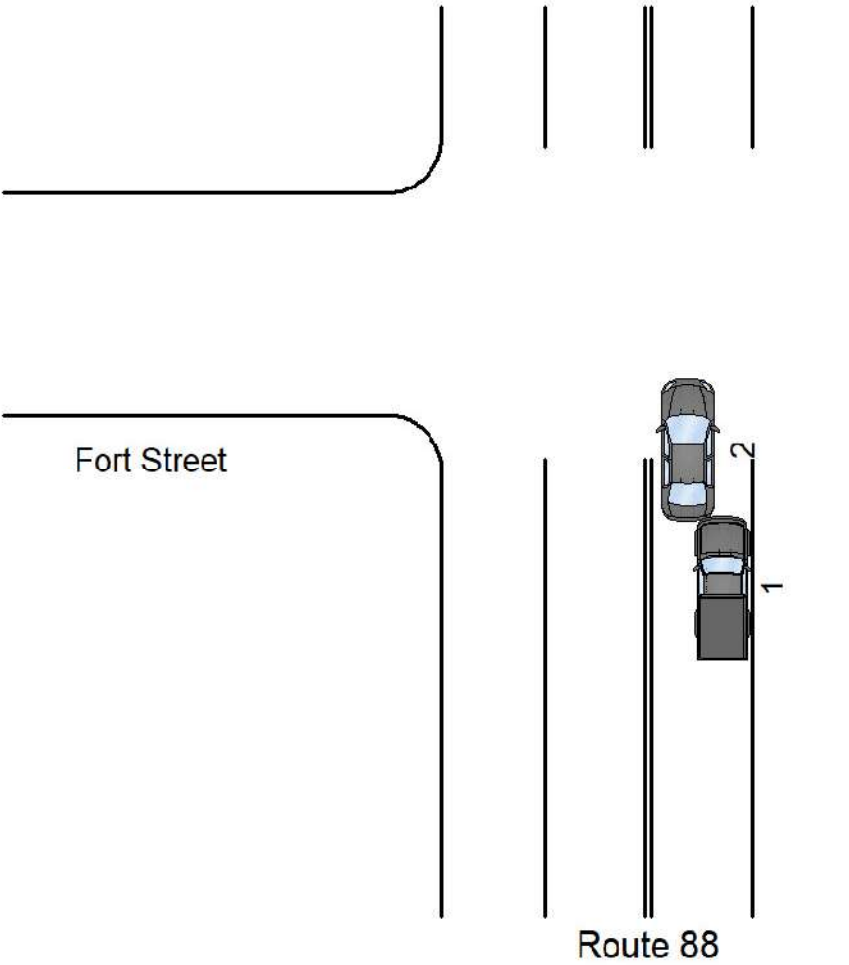
