145. Crash Description/Narrative

Two vehicle crash occurred on 2/13/2022 at approximately 1414 hours on Route 88 eastbound near the intersection with Barb Ln. My body worn camera was on during this investigation.

Driver of vehicle #1 advised she traveling eastbound on Route 88 passing Wawa (1902 Route 88) and observed vehicle #2 stop behind a vehicle turning left into the Wawa. Driver of vehicle #1 stated she believed the vehicle in front of vehicle #2 had stopped short in order to make the left causing vehicle #2 to stop suddenly. Driver of vehicle #1 advised she attempted to stop, however due to the road conditions (wet), she skid and struck vehicle #2 in the rear with the front of her vehicle.

Driver of vehicle #2 advised she was stopped in traffic behind another car who was making a left turn into the Wawa. Driver of vehicle #2 stated while stopped she was struck from behind by the front of vehicle #1.

There were no reported injuries on scene.

Driver of vehicle #1 is at fault for the crash for following too closely and unsafe speed.

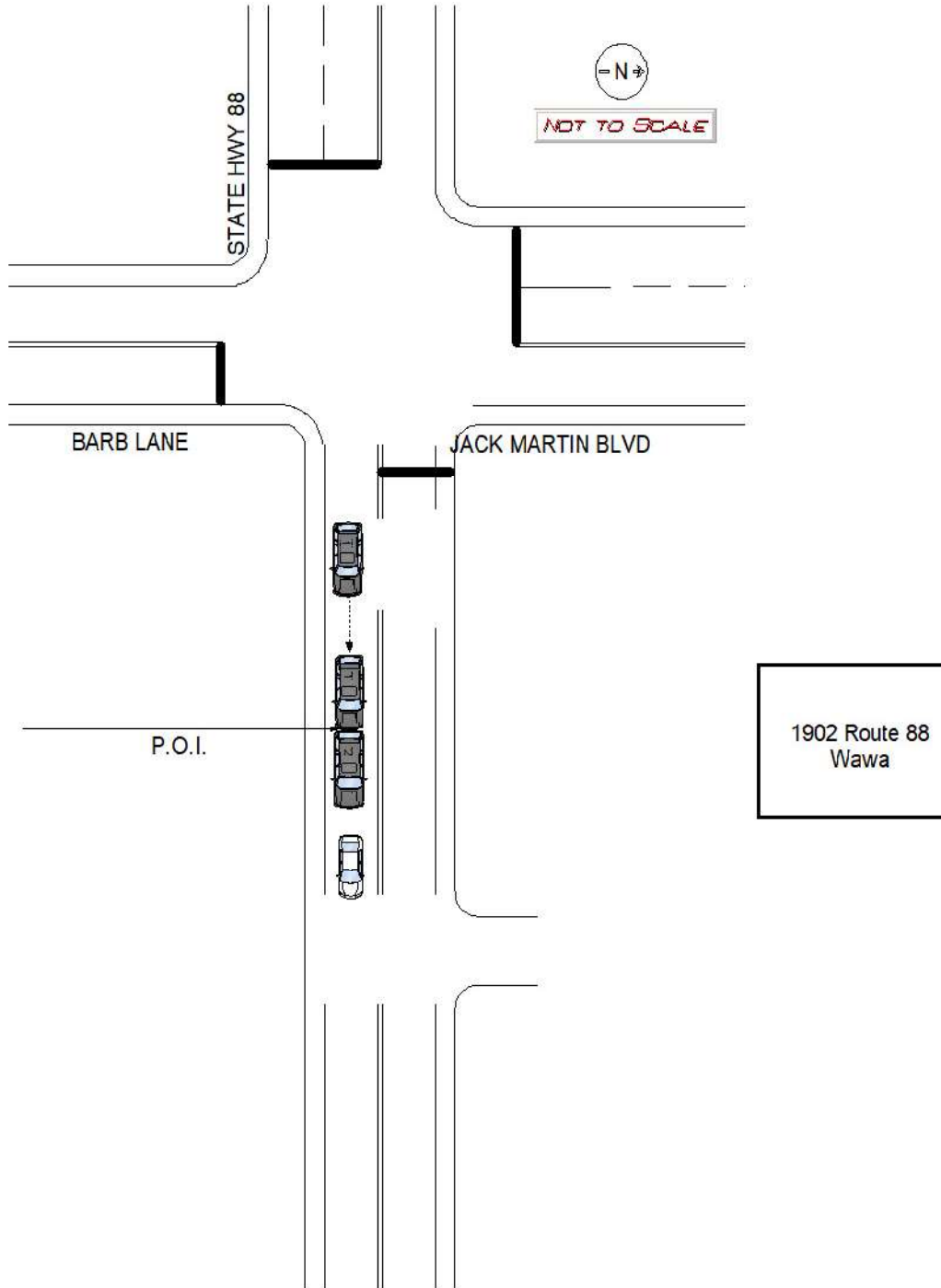
