145. Crash Description/Narrative

On February 16, 2022 I responded to the intersection of Route 88 and Jack Martin Blvd for a motor vehicle crash.

Upon my arrival, vehicle #1 was on the shoulder of Route 88 with front driver side damage. Vehicle #2 was on the shoulder of Jack Martin Blvd with front driver side damage.

Driver #1 explained he was attempting to make the left turn onto Route 88 from Jack Martin when vehicle #2 came across. Driver #1 explained he was already in motion to turn onto Route 88 when vehicle #2 came through the light. As he was turning he had to turn his steering wheel right to avoid him getting "T-boned." As he did that his vehicle struck vehicle #2.

Driver #2 explained he was coming through the traffic light of Route 88 and Jack Martin when vehicle #1 turned into his vehicle.

There were no reported injuries at this time and both parties had a witness of the crash. Both parties completed the motor vehicle crash witness statement form. After my investigation, I found Driver #1 the at fault driver.

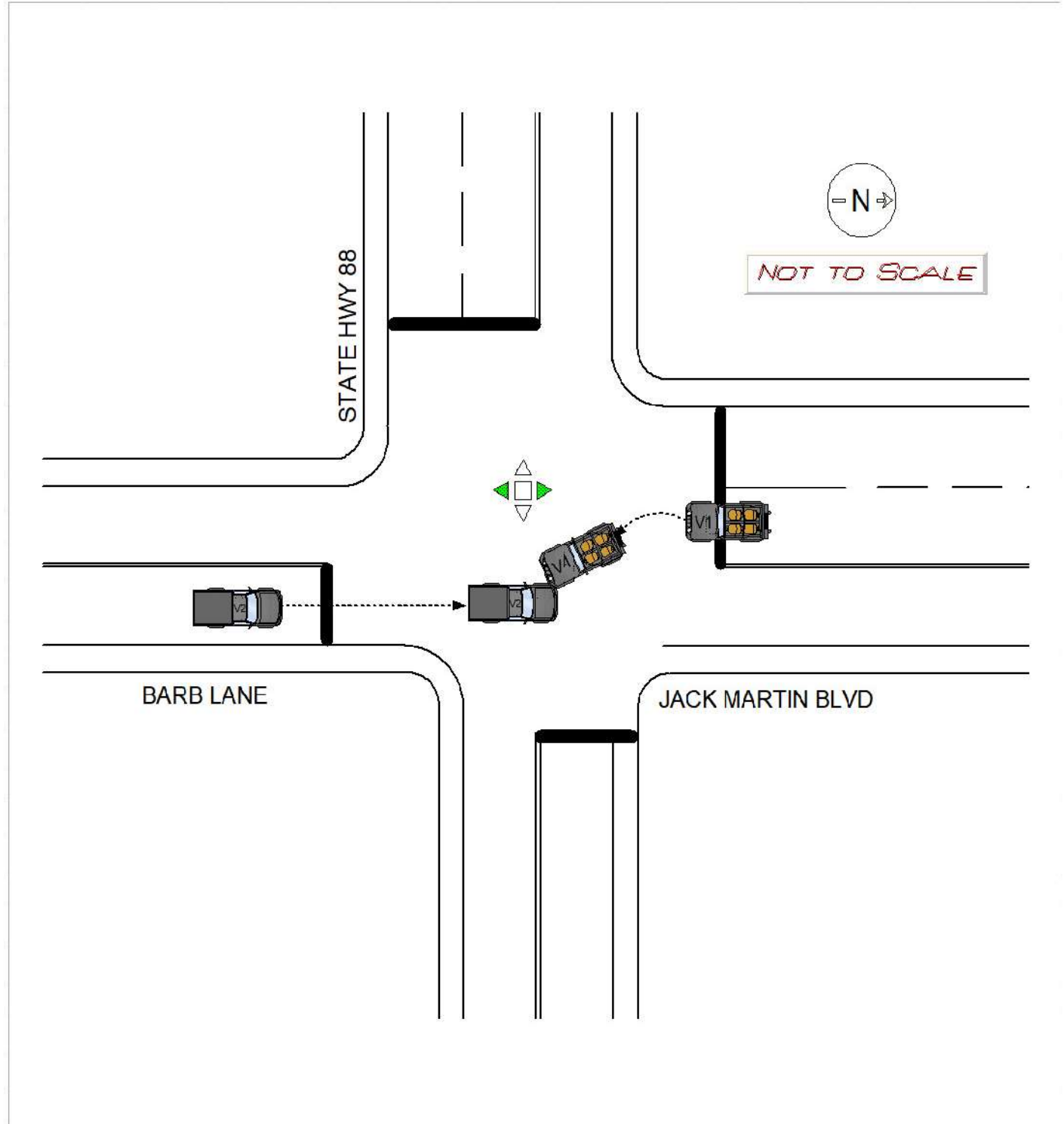
