145. Crash Description/Narrative

V1 and V2 were on Princeton Ave. traveling Eastbound, just prior to Post Road.

D1 alleges that she was traveling East on Princeton Ave in the left lane of travel and V2 changed to the left lane and then sharply hit the brakes to make the left turn into the parking lot. As a result V1 struck the rear of V2.

D2 alleges that he was traveling East on Princeton Ave and safely made a lane change into the left lane of travel. He then slowed to make the left turn into the parking lot, when he was struck in the rear by V1.

All parties involved did not report any injuries. V1 sustained damage to the front driver's side. V2 sustained damage to the rear passenger side. V1 was towed by Joe and Sons Towing.

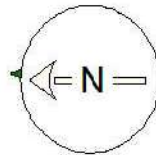
