145. Crash Description/Narrative

Vehicles #1 and #2 were traveling West on Route 88. Vehicle #2 was attempting to make left hand turn onto Fort St. Vehicle #1 continued West on Route 88, thus crashing into the rear of vehicle #2.

The driver of vehicle #1 stated she was traveling West on Route 88. While driving she noticed vehicle #2 in the right shoulder. Upon approaching vehicle #2, vehicle #2 attempted to come back into the traffic lane and make a left onto Fort St. She then honked her horn in an attempt to make the other vehicle stop. The other vehicle continued moving, thus causing vehicle #1 to crash into the rear of vehicle #2.

The driver of vehicle #2 stated she was on Route 88, she was attempting to make a left turn onto Fort St. While making the turn she was struck in the rear of her vehicle.

On scene observations of both vehicles showed damage to the right front bumper and wheel of vehicle #1. Vehicle #2 sustained damage to the left rear bumper and rear fender. Due to the damage on both vehicles, it appeared the statements made by driver #1 were a more accurate statement of the accident.

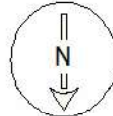
