145. Crash Description/Narrative

Vehicle #2 was traveling on Route 88 eastbound, near the intersection of Washington Drive. Vehicle #1 was stopped at the stop sign on Washington Drive southbound, near the intersection of Route 88. Vehicle #1 traveled forward and collided with vehicle #2.

Driver of vehicle #2 stated he was traveling on Route 88 eastbound, near the intersection of Washington Drive. When he traveled through the intersection, vehicle #1's front bumper collided with his left front fender.

Driver of vehicle #1 stated she was stopped at the stop sign on Washington Drive southbound, near the intersection of Route 88. She did not see any vehicles approaching the intersection at that time. As she was traveling through the intersection, her front bumper collided with vehicle #2's left front fender.

Driver of vehicle #2 had a complaint of pain in his back and a tingly feeling through out his body. Brick EMS arrived on scene to treat him for his injuries. He did not wish for any further treatment and was released on scene by Brick EMS.

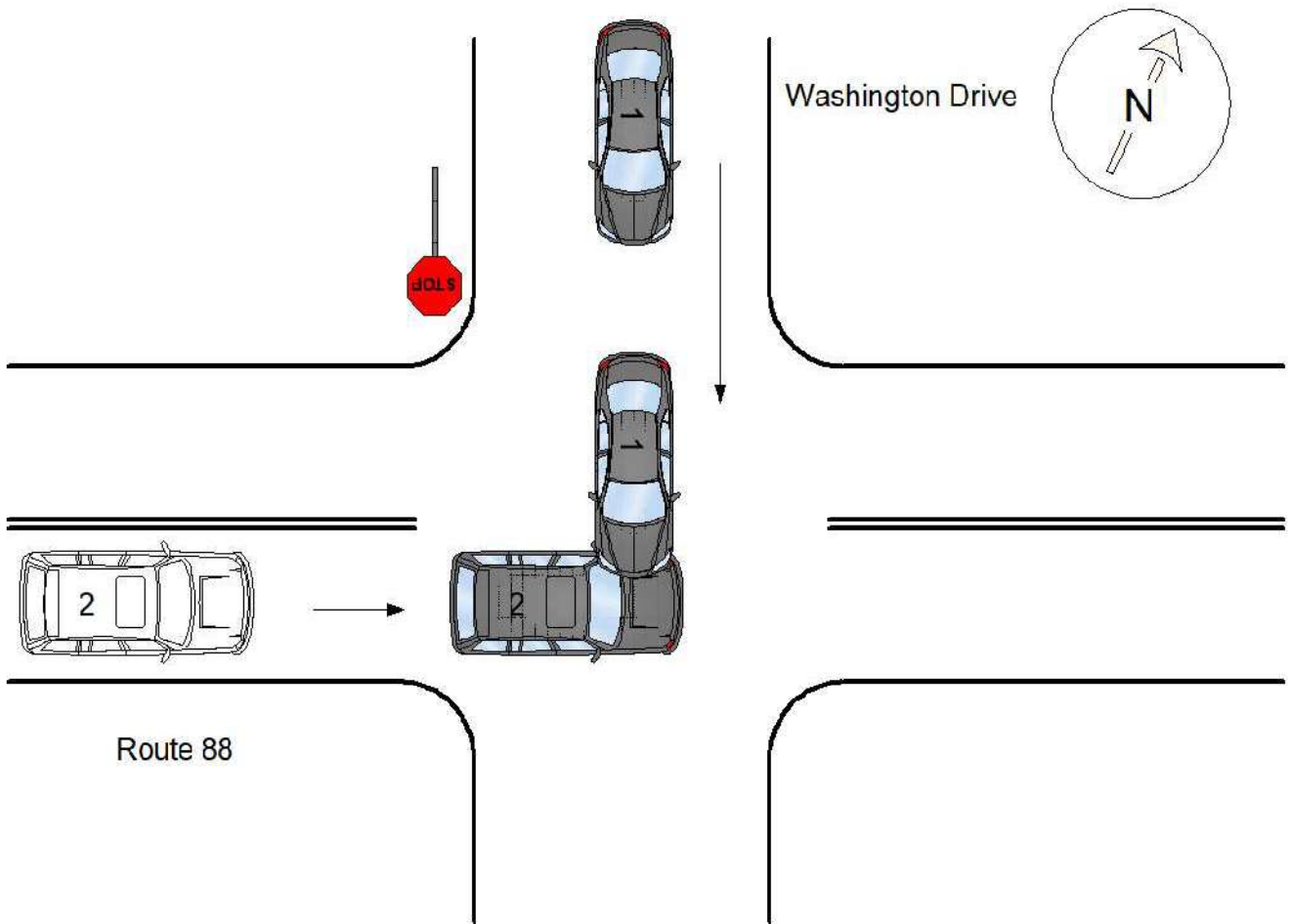
