145. Crash Description/Narrative

Investigation at the scene revealed the following: Vehicle # 1 was traveling E/B on Route 88, going straight. Vehicle # 2 was stopped in traffic on Route 88 E/B, waiting to make a left turn into the Walmart parking lot. Vehicle # 1's driver's side front bumper struck Vehicle # 2's passenger side rear bumper. Vehicles were not moved prior to police arrival.

Driver of Vehicle # 1 stated "I was driving straight on Route 88 and then the next thing I remember is hitting the back of the car in front of me. I'm not sure what happened? I think I fell asleep or blacked out."

Driver of Vehicle # 1 had what appeared to be a panic attack at the scene, so I had an ambulance dispatched to the scene. She refused any medical treatment.

Driver of Vehicle # 2 stated "I was stopped in traffic on Route 88, waiting to make a left turn into Walmart. Then the silver van hit me in the back real hard. The other driver said to someone on her cell phone, I fell asleep."

Driver of Vehicle # 1 was found at fault for this crash, due to her not stopping and hitting Vehicle # 2 in
