145. Crash Description/Narrative

Investigation at the scene revealed: The driver of V2 (vehicle 2) was traveling east on Route 88 and was approximately 15 feet east from the intersection of Route 88 / Jack Martin Boulevard. The driver of V1 (vehicle 1) was traveling directly behind V2. The collision occurred when the driver of V1 impacted the rear right end of V2 with their front left end. On scene I observed both damage the rear right end of V2 and front left end of V1.

The driver of V2 explained he was traveling east on Route 88 and was stopped / slowing in traffic, when he was rear ended by the driver of V1. The driver of V1 explained that she failed to observe V2 come to a stop in traffic. She had been traveling in such close proximity to V2 that she did not have enough time to avoid the collision, which caused her to impact V2.

The driver of V2 explained he hit the back of his head on his driver side seat cushion but was uninjured / declined first aid. The driver of V1 explained she was uninjured / declined first aid. Legacy Towing arrived on location and towed / removed V2 from the roadway. Both vehicles were removed from the roadway prior to my arrival.

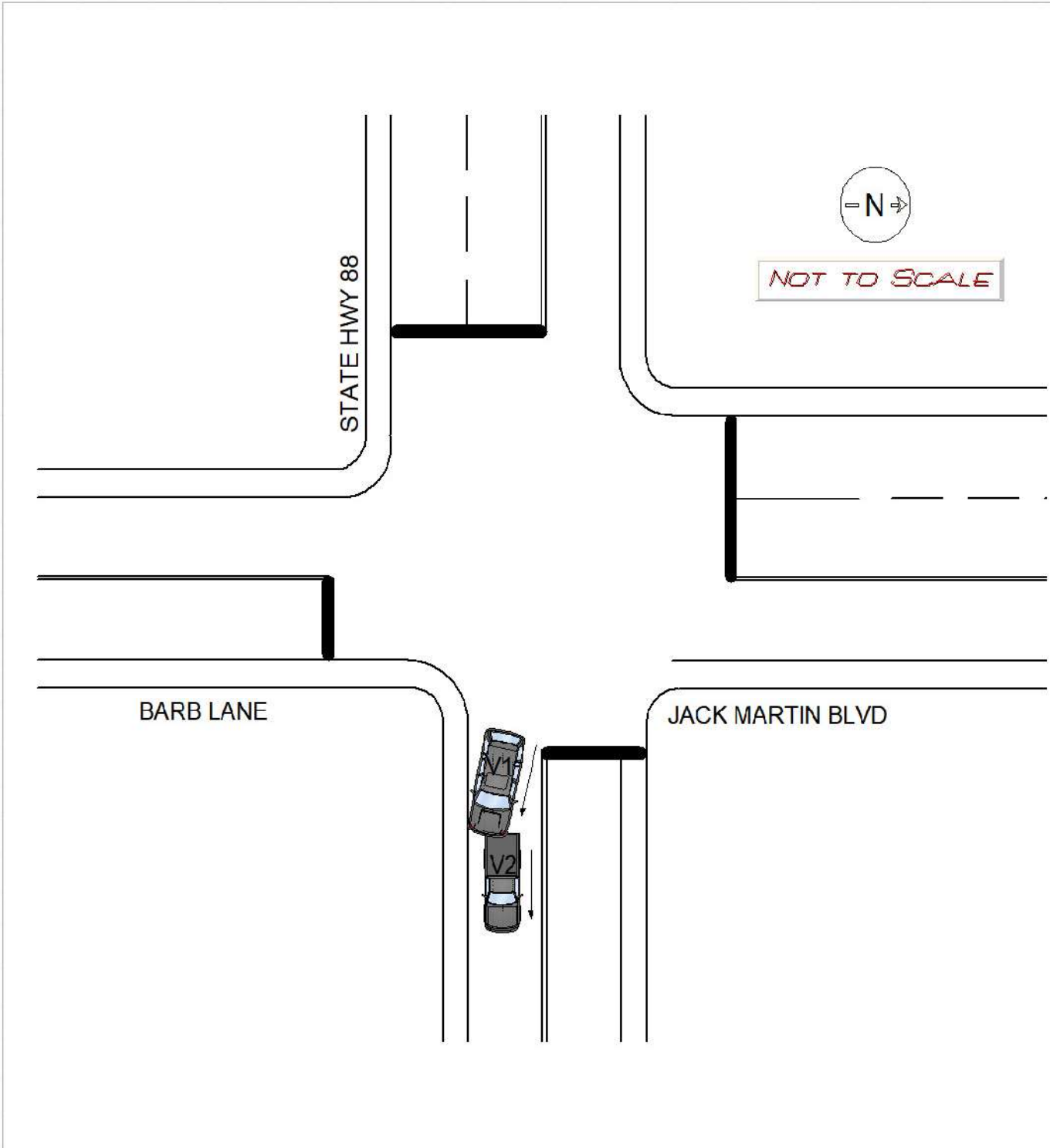
