135 Crash Description

Vehicle 01 was traveling east on Route 70 in the left lane near the intersection of Route 70 and Route 88. Vehicle 02 was traveling east on Route 70 in the center lane near the intersection of Route 70 and Route 88. A blue ford Taurus with NJ registration HX2756 registered to Janis Downey was traveling west on Route 70 in the left lane. At the intersection of Route 88 and Route 70. Janis drove her vehicle into the eastbound lanes and was in the left lane. Vehicle 01 swerved to avoid Janis' vehicle and struck vehicle 02 with the right side of her vehicle causing damage to the left side of vehicle 02.

The driver of vehicle 01 stated she was in the left lane traveling east on Route 70 approaching the intersection of Route 88. The driver of vehicle 01 stated she saw a blue car coming at her head on and to avoid colliding with the blue car she swerved into the center lane making contact with vehicle 02.

The driver of vehicle 02 was traveling east in the center lane on Route 70. The driver of vehicle 02 stated he did not see a blue car coming at vehicle 01 and just felt the impact of vehicle 01 hitting the left side of his vehicle.

I observed the blue Ford Taurus traveling west in the east bound lanes of Route 70 near the Entrance of the Rainbow Diner. I observed the impact of vehicle 01 and vehicle 02. The blue Ford Taurus turned around in front of my patrol vehicle #12 and I conducted a motor vehicle stop of that vehicle on Princeton Ave. I approached the driver who was later identified as Janis Downey and she stated she got confused with the fog and thought she was in the west bound lane until she observed a vehicle coming at her. I issued Janis summons #1506-T-151829 for careless driving (39:4-97).
