135 Crash Description

On scene investigation concluded: Vehicle #1 and #2 were traveling on Rt. 70 (Eastbound) in the area of Jack Martin Blvd. Vehicle #2 stopped at the red traffic signal at the Jack Martin Blvd. intersection and Vehicle #1 failed to stop. Vehicle #1 struck the rear of Vehicle #2.

Driver of Vehicle #1 advised he was traveling on Rt. 70 attempting to stop when his foot slipped of the brake pedal. Driver of Vehicle #1 stated he struck the rear of Vehicle #2.

Driver of Vehicle #2 stated she was stopped at the red traffic signal on Rt. 70 when Vehicle #1 struck the rear of her vehicle.
