135 Crash Description

Vehicle 2 was going straight on Rt. 88 in the area of Van Zile Rd. Vehicle 1 was attempting to pass vehicle 2. The crash occurred when vehicle 1 impacted vehicle 2. On scene I observed damage to the left of vehicle 1 and the right of vehicle 2.

The driver of vehicle 1 stated vehicle 2 was stopped in traffic and another vehicle was in front. The driver of vehicle 1 stated vehicle 2 was not moving so he beeped his horn and attempted to pass on the right. The driver of vehicle 1 stated vehicle 2 sped up quickly causing the crash.

The driver of vehicle 2 stated he was stopped in traffic for a vehicle making a left turn. The driver of vehicle 2 stated after the vehicle had turned he began going straight when he was passed then impacted by vehicle 1.

No injuries were reported. The driver of vehicle 1 was issued summons E16-7783 for careless driving.

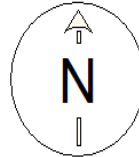
Motor Vehicle Crash Diagram
