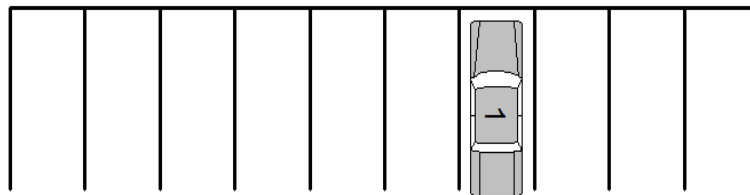

Motor Vehicle Crash Diagram

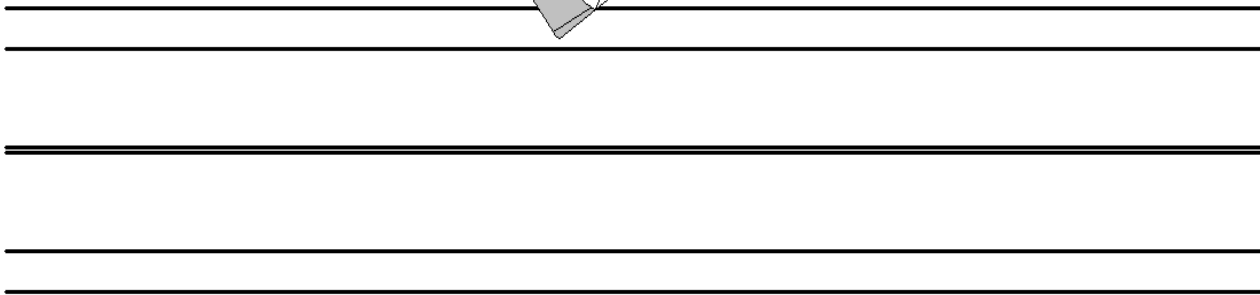
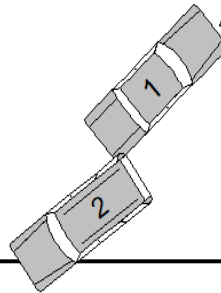
