135 Crash Description

Driver #2 explained he was stopped at the traffic light waiting for the traffic light to turn green when he was struck in the rear by Vehicle #1. Driver #2's passenger explained when the vehicle was struck her neck immediately started to hurt.

Driver #1 explained she looked down to get her coffee when she looked up and saw vehicle #1 stopped at the traffic light. She immediately attempted to stop her vehicle but could not. Her vehicle struck the rear of Vehicle #1.

Brick EMS responded to the scene to treat the passenger of Vehicle #2, but she refused treatment at this time.

On my arrival, I observed minor damage to the front of Vehicle #1 and minor damage on Vehicle #2.
